Bust Me Gall has been stood down from racing for a period of 7 days.

**QUALIFYING HEAT – NO.3**

Protected Specie was slow out. On the first turn Protected Specie checked off the heels of Spirit Whisperer. On the home turn Protected Specie checked off the heels of Spirit Whisperer checking Protected Specie, Spirit Whisperer and Stylish Bobby. Stylish Bobby raced wide in the home straight. In the home straight Protected Specie marred the running of Spirit Whisperer. Protected Specie underwent a post-race veterinary examination and no apparent injury could be detected. Spirit Whisperer underwent a post-race veterinary examination and was found to have muscle soreness to its right hind gluteal muscle. Spirit Whisperer has been stood down from racing for a period of 10 days. Stewards spoke to trainer Mr A Bullock in relation to Protected Species race manners in the home straight. Acting on their own observation and viewing the official race replays, Stewards were of the opinion that Protected Specie had turned its head inwards and made head or muzzle contact with Spirit Whisperer and by doing so had marred the running of that greyhound pursuant GAR69(1). Acting under the provisions of GAR69(2)(a), Protected Specie has been stood down from racing for a period of 28 days Hobart only and until the completion of satisfactory trial.
