RACE 1 – THE ADVOCATE - GRADE 6 452m

Nitro Kobi was slow out. Soon after the start, Chicken Gorge, Not So Cashless and Mono's Illusion bumped. In the back straight, Not So Cashless and Mono's Illusion bumped. Approaching the first turn, Chicken Gorge and Nitro Kobi bumped. Shortly after, Chicken Gorge checked off the heels of Elmer Fudd, checking Nitro Kobi. At the same time, Sticker Sting checked off the heels of Not So Cashless. Full Strength underwent a post-race veterinary examination which revealed the greyhound to have soreness to the thoracal lumbar area. Full Strength has been stood down from racing for a period of 10 days. Trainer Mr W Howells was spoken to in relation to the race manner of Full Strength in the home straight. Acting on their own observations, viewing the official replays, and taking evidence from Mr Howells, Stewards were of the opinion that Full Strength had turned its head outward toward Mono's Mystique in the home straight and in doing so failed to pursue the lure with due commitment throughout the event by reason of injury, pursuant to GAR69B(1)(a). Full Strength has been stood down from racing until the completion of a satisfactory trial. A post-race swab sample was taken from Mono's Mystique, the winner of the event.

RACE 2 – ULVERSTONE PET FOODS - GRADE 4 (1) 452M

Soon after the start, Paddy Lee, Bound For Blue, Declassified, Bank Book and Sadi's My Lady bumped, severely checking Declassified which tailed the field for the remainder of the event. In the back straight, Hard Bass crossed toward the rail, checking Sadi's My Lady. Approaching the first turn, Paddy Lee, Sadi's My Lady and Minish Woods bumped, checking Sadi's My Lady and Minish Woods. On the first turn, Bound For Blue checked off the heels of Sadi's My Lady. Approaching et home turn, Sadi's My Lady checked off the heels of Paddy Lee. Shortly after, Paddy Lee checked off the heels of Bank Book, checking Sadi's My Lady. Entering the home straight, Buckle Up Kavi crossed wide, checking Paddy Lee. Declassified underwent a post-race veterinary examination which revealed the greyhound to have an injury to the left hind gracilise muscle. Declassified has been stood down from racing for a period of 28 days.

Soon after the start, Little Miss Asha, Ordon Sword, Tah Liam, Terrain and Granola bumped, checking Ordon Sword and Little Miss Asha. On the first turn, Terrain and Granola bumped, checking Granola. Shortly after, Little Miss Asha checked off the heels of Ordon Sword. On the home turn, Granola galloped on the heels of Bridwood Elle, checking both greyhounds, and as a result, Bridwood Elle stumbled. Terrain raced wide rounding the home turn. Bridwood Elle underwent a post-race veterinary examination and no apparent injury could be detected.

The start of this event was delayed due to an interstate harness race running behind schedule. Classy Lady was slow out. In the back straight, She's Cuban, Unbeknownst and Pages Creek bumped, checking Pages Creek. On the home turn, Hiccup Amisha and Rookie Ronaldo bumped. Entering the home straight, She's Cuban and Pages Creek bumped. Hiccup Amisha underwent a post-race veterinary examination and no apparent injury could be detected.

veterinary examination and no apparent injury could be detected. A post-race swab sample was taken from Nitro Wheels the winner of the event.

At the same time, Nitro Ash checked off the heels of Roy's Rocket. Shortly after, Roy's Rocket, Russia With Love and Buckle Up Miri bumped. Approaching the first turn, Sassy Galaxy crossed toward the rail, checking Buckle Up Miri, Always Baroque and Russia With Love. As a result, Buckle Up Kenzie was checked. Approaching the home turn, Always Baroque checked off the heels of Buckle Up Aislin, checking Buckle up Kenzie and Buckle Up Miri. A post-race swab sample was taken from Sassy Galaxy, the winner of the event.

Shortly after, I'm A Dominator, Amy Cora and Get On Phil bumped, checking Amy Cora which bumped with Buckle Up Rhonan. Approaching the first turn, Beep Test Baron crossed toward the rail, checking Highland Wonder and Get On Phil. Entering the home straight, Beep Test Baron and Amy Cora bumped. Highland Wonder raced wide rounding the home turn and in the home straight. A post-race swab sample was taken from Fairytale Youth, the winner of the event.

Theo Dragonet was slow out. Soon after the start, Over The Anvil crossed wide, checking Theo Dragonet and bumped with Just Rambling. In the back straight, Over The Anvil and Just Rambling bumped. Approaching eth first turn, Just Rambling crossed toward the rail bumping with Over The Anvil. At the same time, Freddie Fox Trot checked off the heels of My Bro Joe. Shortly after, Just Rambling checked off the heels of Hey Dougie. Entering the home straight, All About Monty, My Bro Joe and Brindle Burner bumped. A post-race swab sample was taken from Brindle Burner, the winner of the event.

Evolution Girl, All My Heart and Stylish Hugh were slow out. In the back straight, Tah Zac crossed wide checking Buckle Up Wilder and Dewana Macca. As a result, Buckle Up Wilder stumbled. On the first turn, She's It checked off the heels of My Name's Serg. On the home turn, She's It and All My Heart bumped, checking All My Heart. Approaching the finish, Dewana Macca and Tah Zac bumped.

RACE 10 – CROWN LAGER - AUSTRALIA'S BEST - MIXED 4/5 452M

A pre-race swab sample was taken from Hiccup Herman. Bleak Midwinter, Postman Pete and Buckle Up Simola were slow out. Approaching the first turn, Malizia crossed toward the rail, checking Hiccup Herman and Rissa's Girl. Bleak Midwinter underwent a post-race veterinary examination after receiving interference in the catching pen and no apparent injury could be detected. Devil's Corner underwent a post-race veterinary examination after collapsing in the catching pen. Acting under GAR74(1), Devil's Corner has been stood down from racing for a period of 14 days and must complete a satisfactory trial due to suffering from hypoxia for the second occasion.

Oakwood completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 9th of February 2021 for failing to pursue the lure with due commitment throughout the event, pursuant to GAR69A(1). Weighing 26.9kg and beginning from box 3, Oakwood completed the 452M trial distance in a time of 25.87. Oakwood has been cleared to race at all tracks.
