Superior Specter completed a Stewards satisfactory trial as it had been stood down from racing at the Healsville race meeting on the 11<sup>th</sup> of April 2021 for marring, pursuant to GAR69(1). Weighing 34.2kg and beginning from box 3, Superior Specter completed the 452M trial distance in a time of 26.18. Superior Specter has been cleared to race at all tracks.

Kaleidoscope Kid completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 7<sup>th</sup> of June 2021 for marring, pursuant to GAR69(1). Weighing 29.8kg and beginning from box 3, Kaleidoscope Kid completed the 452M trial distance in a time of 26.49. Kaleidoscope Kid has not been cleared to race as the greyhound marred in the home straight and as a result did not perform to the satisfaction of Stewards.

Devil's Corner completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 25<sup>th</sup> of May 2021 for displaying signs of hypoxia, pursuant to GAR74(1). Tah Zac completed a Stewards satisfactory trial as it had been stood down from racing at the NWGRC meeting on the 8<sup>th</sup> of June 2021 for displaying signs of hypoxia, pursuant to GAR74(1). Weighing 31.2kg and beginning from box 5, Tah Zac completed the 452M trial distance in a time of 26.46. Tah Zac has been cleared to race at all tracks.
