Soon after the start, Rosa Vista, Zevon and Stylish Bobby bumped. Approaching the first turn, Ain's She Swift and Granola bumped. In the back straight, Stylish Bobby checked off the heels of Zevon. On the home turn, Zevon, Fire Flick and Swan Vista bumped, checking Swan Vista. Stylish Bobby raced wide in the home straight. Stylish Bobby underwent a post-race veterinary examination revealed the greyhound to have a diaphragmatic flutter. After consulting with the club's veterinary surgeon, who advised Stewards that this condition would have no bearing on the greyhound's performance Stewards took no further action.

**RACE 2 – MEMBERSHIPS DUE 31ST JULY - GRADE 6 340M**

Approaching the first turn, Ticket To Tokyo and Little Blue Man bumped, checking Ticket To Tokyo. Approaching the home turn, Caroline's Call and Hawk Danger bumped, checking Caroline's Call. On the home turn, Hello Claudy galloped on the heels of Hawk Danger, checking Itself. As a result, Hello Claudy bumped with Caroline's Call. Hello Claudy and Caroline's Call raced wide in the home straight. Little Blue Man struck the catching pen gate after the race. Little Blue Man underwent a post-race veterinary examination revealed the greyhound had suffered minor bruising to the left side of the nose, however no stand down was issued.

**RACE 4 – CASCADE DRAUGHT - MAIDEN 461M**

A pre-race swab sample was taken from Blazing Ember. Soon after the start, Kindred and Midnight Lenny bumped, checking Kindred. Approaching the first turn, Blazing Ember crossed wide, bumping with Bridwood Everest which was checked. On the first turn, Midnight Lenny faltered and failed to finish the event. Approaching the home turn, Hot Avatar checked off the heels of Bridwood Everest. On the home turn, Kindred checked off the heels of Port Jinx. Approaching the winning post, Port Jinx and Bridwood Everest bumped. Blazing Ember and Bridwood Everest collided in the catching pen, causing both greyhounds to fall. Blazing Ember underwent a post-race veterinary examination and no apparent injury could be detected. Bridwood Everest underwent a post-race veterinary examination and no apparent injury could be detected. Midnight Lenny underwent a post-race veterinary examination which revealed the greyhound to have split webbing on the right hind paw and a gracilis muscle injury. Midnight Lenny has been stood down from racing for a period of 28 days.

Wing Commander and Dewana Be Me raced wide in the home straight. A post-race swab sample was taken from Superior Digby, the winner of the event.

On the first turn, All On Me checked off the heels of Raleigh, checking with Negotiator and as a result, Negotiator bumped with David Moss. On the home turn, Negotiator checked off the heels of All On Me. Entering the home straight, David Moss and All On Me bumped. David Moss faltered and tailed the field from there on. David Moss underwent a post-race veterinary examination which revealed the greyhound to have a fractured right hock. David Moss was subsequently euthanised.
