Enchanted Spirit completed a Stewards satisfactory trial as it had been stood down from the NWGRC on the 16th February 2021 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 33kg and beginning from box 5 Enchanted Spirit completed the 452m trial distance in a time of 26.32. Enchanted Spirit has not been cleared to race, as it turned its head inward towards the leader in the home straight and, as such failed to pursue the lure with due commitment throughout the event.

Nanny Miller completed a Stewards satisfactory trial as it had now started in an event for in excess of 6 months pursuant to LR 31.3. Weighing 26.3kg and beginning from box 3, Nanny Miller completed the 452m trial distance in a time of 37.02. Nanny Miller has not been cleared to race as it failed to meet the qualifying race time.

Dewana Magoo completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 5th of July 2021 for marring, pursuant to GAR69(1). Weighing 32.5kg and beginning from box 3, Dewana Magoo completed the 452m trial distance in a time of 26.57, placing 2nd. Dewana Magoo has been cleared to race at all tracks except Launceston.

Winklee Hugo completed a Stewards satisfactory trial as it had been stood down from racing at the LGRC meeting on the 5th of July 2021 for marring, pursuant to GAR69(1). Weighing 37.3kg and beginning from box 5, Winklee Hugo completed the 452m trial distance in a time of 25.93, placing 1st. Winklee Hugo has been cleared to race at all tracks except Launceston.
