Soon after the start, Freddie Fox Trot and Trying Again bumped, checking Trying Again. On the first turn, Freddie Fox Trot, She's It and Bust Me Gall bumped, checking Freddie Fox Trot. Soon after, Trying Again checked off the heels of Home Time. On the home turn, Trying Again and Home Time bumped. Soon after, Trying Again and Home Time. Home Time raced wide in the home straight. A post-race swab sample was taken from Winkle Sprite, the winner of the event.

RACE 2 – LEEROY ROGUE AT STUD GRADE 6 461M

Soon after the start, Rip Away, Run Rex Run and Sandy Titan bumped, checking Rip Away. Approaching the first turn, Run Rex Run, Sandy Titan and Coote bumped, checking Run Rex Run. On the first turn, Zevon crossed wide, checking Run Rex Run. Approaching the home turn, Zevon marred the running of Run Rex Run. In the home straight, Coote and Run Red Run bumped. Zevon underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr E Medhurst in relation to Zevon's racing manners, in particular approaching home turn. Acting on their own observations, viewing the official replays and taking evidence from Mr Medhurst, Stewards were of the opinion that Zevon had turned its head outwards and had made head and muzzle contact with Run Rex Run, and by doing so had marred the running of that greyhound pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(a), Zevon, has been stood down from racing for a period of 28 days at Hobart only and until the completion of a satisfactory trial. A post-race swab sample was taken from Jewel Titan, the winner of the event.

RACE 4 – GREAT NORTHERN ZERO MIXED 3/4 461M

Soon after the start, Adrianna, Eternity and Casino Ace bumped, checking Eternity. In the back straight, Adrianna checked off the heels of Dark Titan. Approaching the first turn, It's A Cruise and Casino Ace bumped, checking Casino Ace. As a result, Adrianna checked off the heels of Casino Ace. County Mist raced wide in the home straight.

RACE 5 – SHANE YATES MEMORIAL TASBRED CUP HEAT 1 3/4/5 461M

A pre-race swab sample was taken from Action Plus. In the back straight, Brindle Burner, Jane's Reign and Twisted Reality bumped, checking Twisted Reality. Soon after, Granola and Action Plus bumped, checking Granola. Approaching the first turn, Kaleidoscope Kid crossed to the rails, checking Action Plus. Approaching the home turn, Twisted Reality checked off the heels of Brindle Burner. As a result, Granola and Twisted Reality bumped. In the home straight, Kaleidoscope Kid marred the running of Tah Liam. Kaleidoscope Kid underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer Mr A Bullock in relation to Kaleidoscope Kid's racing manners, in particular the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Bullock, Stewards were of the opinion that Kaleidoscope Kid had turned its head outwards and had made head and muzzle contact with Tah Liam, and by doing so had marred the running of that greyhound pursuant to GAR 69(1). Acting under the provisions of GAR 69(2)(b), Kaleidoscope Kid, has been stood down from racing for a period of three months at all tracks and until the completion of a satisfactory trial, as this is the greyhounds second marring offence.

Meeting Abandoned

General:

This meeting was abandoned by order of Stewards due to the continual malfunctioning of the lure.

The lure was replaced, and testing of the lure was carried out after the running of Race 3 where the greyhounds caught the lure, resulting in a NO RACE. This testing indicated that the lure was functioning correctly, however the lure malfunctioned again during a Stewards' trial (After Race 5). The lure was again replaced and again, tested successfully. During the running of Race 6 the lure once more malfunctioned, and the greyhounds caught the lure, resulting in a NO RACE.

After consultation with Tasracing Officials and multiple greyhound trainers after the running of Race 6. And, after giving due consideration to the circumstances and to the Greyhound Australasia rules, Stewards elected to abandon the meeting for the safety and welfare of the greyhounds.

This meeting included four heats of the Shane Yates Memorial Tasbred Cup. Due to the abandonment of the meeting, only Heat 1 of this series was completed. Acting under the provisions of GAR57(2)(b) a public ballot was conducted. This ballot included all the remaining greyhounds from the final three heats, to determine a field for the final. This ballot was conducted under the supervision of stewards.
