In the back straight, Get On Phil checked off the heels of Gershwin Rhythm. Approaching the first turn, Ailani, Adabelle and Sadi's My Lady bumped, checking Adabelle and Thunder Thrash. Soon after, Get On Phil checked off the heels of Thunder Thrash. Entering the home straight, Ailani and Bronze Smoke bumped. Approaching the winning post, Ailani and Bronze Smoke bumped. Get On Phil underwent a post-race veterinary examination and was found to have a small laceration above the right eye. No stand down period was applied.

In the front straight, Rojo Diamond crossed wide and as a result, Rojo, Coote and She's All Mine bumped, checking Coote and She's All Mine. Approaching the first turn, Coote and She's All Mine bumped, checking She's All Mine. Pistachio Tang raced wide around the first turn. On the second turn, Inferno Girl, Roxy Danger and Coote bumped, checking Roxy Danger and Coote. In the back straight, Playboy Danger, Roxy Danger and Coote bumped, checking Playboy Danger and Roxy Danger. On the third turn, Pistachio Tang checked off the heels of Coote. Soon after, Pistachio Tang and Playboy Danger bumped. She's All Mine underwent a post-race veterinary examination, and no apparent injury could be detected. Stewards spoke to trainer, Mr M Pearce, in relation to She's All Mine's racing manners, in particular in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Pearce, Stewards were of the opinion that She's All Mine had turned its head outwards and had made head and muzzle contact with Coote, on at least two occasions and by doing so had marred the running of that greyhound, pursuant to GAR69(1). Acting under the provisions of GAR69(2)(a), She's All Mine has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial. A post-race swab sample was taken from Rojo Diamond, the winner of the event.
