As a result, Ariarne raced wide on the first turn. On the home turn, Mono's Mystique and Max Outlaw bumped. Soon after, Bridwood Skye checked off the heels of Max Outlaw. Caroline's Call raced wide in the home straight. A post-race swab sample was taken from Toxic Turtle, the winner of the event.

In the home straight, Sandy Titan and Voodoo Girl bumped, checking Voodoo Girl. Sandy Titan underwent a post-race veterinary examination and was found to have a single spike wound to the left foreleg. However, no stand down period was applied. Voodoo Girl underwent a post-race veterinary examination and was found to have mild soreness to the left hind tenor fascia muscle. Voodoo Girl has been stood down from racing for a period of 5 days.

As a result, Another Comet checked off the heels of Engage The Rage. On the first turn, Mick's Legacy and Engage The Rage bumped. On the third turn, Third Day and Mick's Legacy bumped, checking Mick's Legacy. On the home turn, Black Hawk Jet and Never Sweat bumped. All On Me underwent a post-race veterinary examination and was found to have a left hind leg gracilis muscle injury. All On Me has been stood down from racing for a period 60 days.

Rojo McGee underwent a post-race veterinary examination and no apparent injury could be detected.

At the same time, Always Baroque and Just Mercy bumped. Approaching the first turn, Always Baroque and Just Mercy bumped. Soon after, Always Baroque, Just Mercy and Raleigh bumped, checking Raleigh. Red Card Reggie raced wide in the back straight. Approaching the third turn, Buckle Up Aislin and Always Baroque bumped, checking Always Baroque. Soon after, Buckle Up Kenzie checked off the heels of Just Mercy. On the home turn, Buckle Up Aislin and Just Mercy bumped. A post-race swab sample was taken from Earning The Cash, winner of the event.

Approaching the first turn, Pretty Boy Roy and Enchanted Spirit bumped. At the same time, Winklee Frankie and Country Fred bumped. Approaching the first turn, Country Fred crossed wide, checking Pretty Boy Roy, Enchanted Spirit, Full Strength and Miss Malfunction. Soon after, Enchanted Spirit and Rosa Vista bumped. Approaching the second turn, Miss Malfunction galloped on the heels of Pretty Boy Roy, severely checking Miss Malfunction. Approaching the third turn, Full Strength and Winklee Frankie bumped, checking Full Strength. On the home turn, Pretty Boy Roy and Full Strength bumped, checking both greyhounds. Approaching the winning post, Sneaky Sticker and Country Fred bumped. Miss Malfunction underwent a post-race veterinary examination and was found to have a right hind hock fracture. Miss Malfunction has been stood down from racing for a period of 6 months. Sneaky Sticker underwent a post-race veterinary examination and no apparent injury could be detected. Stewards spoke to trainer, Mr R Work, in relation to Sneaky Sticker's racing manners, in particular in the home straight approaching the winning post. Acting on their own observations, viewing the official replays and taking evidence from Mr Work, Stewards were of the opinion that Sneaky Sticker had turned it's head outwards and had made it head and muzzle contact with Country Fred and by doing so had marred the running of that greyhound, pursuant to GAR69(1), acting under the provisions of GAR69(2)(a), Sneaky Sticker has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial.

Weighing 28.2kg and beginning from box 05. Rob's Joker completed the 278 M trial distance in a time of 16.77. Rob's Joker has not been cleared as it didn't meet the satisfactory trial time.
