Comments / Explanations:

Late rider declaration for Red Helmet, trainer A Roach fined \$50 LR 13.3.

RACE 1 - CHILLI 90.1 FM MAIDEN - 1200 METRES

Babe's Boy (I luximon) - Slow to begin.

Gee Gees Rebel (D Parish) – Layed out near the 400 metres. Underwent a post-race veterinary examination after appearing to be galloped on near the 400 metres and was found to have no abnormalities.

Mikayla's Paris (P Lui) -Layed in near the 400 metres crowding Our Sonny Boy then shifted out tightening the running of Alpine Assault.

Our Sonny Boy (B Muhcu) – Tightened for room and appeared to clip heels near the 400 metres between Mikayla's Paris and Gee Gees Rebel, both which had shifted ground. Mikayla's Paris then shifted out to relieve pressure and inconvenienced Alpine Assault to its outside. Riders P.Lui and D Parish were advised to exercise care when their mounts to shift ground.

Upward and Onward (S So) – Late scratching on veterinary advice after becoming fractious in the mounting yard prior to the race, slipping and suffering abrasions to the near hind. A veterinary certificate will be required prior to racing again.

The following deductions were ordered:

Bondi Tiff (1st) - 1 cent a win & 3 cents a place. Mikayla's Paris (2nd) - 4 cents a place. Our Sonny Boy (3rd) - 3 cents a place.

Fortessa (T Stalker) – Raced three wide without cover throughout.

Labby Rock (D Ganderton) – Jumped awkwardly. Layed in, approaching and making the 800 metre turn

Alpine Assault (M Ulucinar) - Tightened by Mikaylas Paris which had shifted out near the 400 metres.

RACE 2 - LADBROKES PUNTER ASSIST MAIDEN - 1200 METRES

Bell Ringer Boy (B Muhcu) – Jumped awkwardly.

Heza Charmer (B Louis) – Jumped awkwardly and was slow to begin. Tightened shortly after the start when Bestie's Daughter layed in. Bumped near the 800 metres. Hung in and raced greenly throughout.

Needs Toasting (B McCoull) – Raced ungenerously in the middle stages.

Rockin' Ringo (T Doyle) – Was a late scratching at 6:12pm when it reared in the mounting yard and fell, injuring apprentice T Doyle. This gelding was stood down to a satisfactory trial for its pre race manners.

The following deductions were ordered:

Needs Toasting (1st) - 3 cent a win & 4 cents a place. Belll Ringer Boy (2nd) - 7 cents a place. Queen's The Word (3rd) - 8 cents a place.

Besties Daughter (P Lui) – Bumped on jumping. Layed in shortly after the start. Bumped with Heza Charmer near the 800 metres. Raced three wide early.

Church Bells (E Byrne Burke) - Shifted out and bumped with Queens Needs shortly after at the start.

Grandezza (D Pires) – Layed out on the home turn. Rider reported that the mare hung out throughout. Underwent a post-race veterinary examination and was found to have no abnormalities.

Miss Sleuth (I Luximon) – Bumped at the start. Tightened for racing room near the 400 metres between Besties Daughter which layed in and Puma which had been carried outward by Grandezza laying out. Held up for a clear run behind both these runners entering the home straight.

Puma (M Ulucinar) - Carried wider near the 400 metres when Grandezza layed out.

Queen's The Word (C Jordan) – Shifted out and bumped with Miss Sleuth on jumping.

RACE 3 – BISHOPS CLASS 1 HCP – 1400 METRES

Incriminate (B McCoull) – Jumped awkwardly.

Gee Gee Can Win (D Parish) – Slow to begin. Placed at a disadvantage for some distance after the 1200 metres due to having to exercise caution regarding Gee Gee Rhythm's rider's difficulties.

Moshama (J Blacker) – Placed at a disadvantage for some distance after the 1200 metres due to having to exercise caution regarding Gee Gee Rhythm's rider's difficulties.

Tavisplash NZ (D Ganderton) – Checked passing the 1200 metres by Gee Gee Rhythm shifting out due to the rider having lost her stirrup iron. Placed at a disadvantage for some distance thereafter due to having to exercise caution regarding Gee Gee Rhythm's rider's difficulties.

So I'm Dreaming (P Lui) - Shifted in near the 1200 metres tightening Gee Gee Real Deal.

Techno Awards (M Ulucinar) – Placed at a disadvantage for some distance after the 1200 metres due to having to exercise caution regarding Gee Gee Rhythm's rider's difficulties.

Gee Gee Real Deal (B Louis) – Momentarily tightened for room approaching the 1200 metre mark by So I'm Dreaming which was shifting in. This in turn crowded Gee Gee Rhythm, which at the time was over racing severely due to the saddle slipping. Stewards advised P Lui that he should exercise far greater care when allowing his mount to shift ground.

Gee Gee Rhythm (T Johnstone) – Rider lost her near side stirrup iron due to the saddle slipping on jumping. She was placed at a severe disadvantage for the remainder of the race. Shifted in near the 1200 metres when over racing and being restrained bumping with Blushed.

Wood's Point (C Jordan) – Over raced in the early stages. Placed at a disadvantage for some distance thereafter due to having to exercise caution regarding Gee Gee Rhythm's rider's difficulties.

Blushed (T Baker) – Bumped near the 1200 metres by Gee Gee Rhythm.

Boss Cheyenne (B Muhcu) – Raced three wide throughout.

Dinga's Delight (S So) – Reared on jumping as was slow to begin. Placed at a disadvantage for some distance after the 1200 metres due to having to exercise caution regarding Gee Gee Rhythm's rider's difficulties.

RACE 4 - FIELD FAMILY 3YO MAIDEN - 1100 METRES

Alpine Blast (M Ulucinar) –Dissapointed for a clear run approaching the 100 metres and obliged to shift in over the heels of Dawn Eagle to obtain a run.

Bavarian Flyer (G Catania) – Underwent a post-race veterinary examination and was found to have no abnormalities.

Chosen Eagle (D Pires) - Slow to begin. Raced greenly and shifted in abruptly soon after the start.

Gee Gee Buzz (T Johnstone) – Raced three wide in the early stages. Layed out entering the home straight and had to be steadied off the heels of Power Magnum.

Power Magnum (B Muhcu) – Jumped awkwardly shifted in and inconvenienced Queenborough Flyer.

Dawn Eagle (E Byrne Burke) – Layed out under pressure in the home straight.

Need A Flutter (S So) – Slow to begin shifted in abruptly after the start. Over raced in the early stages.

Queenborough Flyer (S Carr) – Bumped by Power Magnum shortly after the star

Saxon Mist (T Baker) - Raced wide in the early stages.

RACE 5 – HAPPY 50TH BIRTHDAY EXCITING MAB MDN/CL1 – 1600 METRES

Calingo (D Pires) – Slow to begin.

Anacreon (E Byrne Burke) – Raced three wide early without cover.

Kay Oh Ell (NZ) (P Lui) – Shifted out on jumping, bumping with Port Berry.

Northern Spirit (T Baker) – Underwent a veterinary examination prior to the start, as the starter reported that it may have struck its head in the barriers and was passed fit to run. Northern Spirit underwent a post-race veterinary examination which revealed it had blood in its mouth due to an abrasion to its lip. Stewards issued a warning on the barrier manners of this mare due to being fractious.

Port Berry (NZ) (M Ulucinar) -Slow to begin, bumped at the start by Kay Oh Ell (NZ).

RACE 6 - MECURE SUNSHINE COAST KAWANA WATERS BM76 HCP - 1400 METRES

The start was delayed when Overplay became fractious in the barriers and became cast. Withdrawn from the gates and underwent a pre-race veterinary examination and was passed fit to run. Overplay must trial before racing again due to being fractious.

Arty Lucas (S So) – Slow to begin.

Overplay (C Jordan) - Slow to begin.

Mywordis (B Louis) – Raced three wide without cover in the early and middle stages.

Coronation Glade (T Baker) – Jumped awkwardly.

RACE 7 - KREGLINGER WINE ESTATES BM68 HCP - 1200 METRES

Invincible Rock (S Carr) - Shifted outward on jumping and bumped with Sellick.

Red Letter Lady (B McCoull) – Passing the 400 metres, was held up for clear run behind Invincible Rock, shifted out bumping with Shewearsthepants.

Vivilici (E Byrne Burke) – Brushed the running rail passing the 400 metres when racing tightly to the inside of Tough Boy.

Sellick (B Muhcu) – Soon after the start was crowded outward by Invincible Rock, bumped with Red Helmet before shifting in and bumping with Invincible Rock. Restrained off the heels of Invincible Rock shortly after.

Ivoryman NZ (D Pires) – Jumped awkwardly.

Red Helmet (T Stalker) – Shifted in on jumping, bumping with Sellick. Shifted in under pressure in the early stages of the home straight, before being corrected by its rider and shifting out.

Shewearsthepants NZ (M Ulucinar) – Raced three wide without cover.

RACE 8 - EXAMINER - 1200 METRES

Correct weight was delayed for T Baker (Gee Gee Als Prince) to view the films with regard to lodging a protest. After doing so he was satisfied, and correct weight was declared.

Needadollarbill (B Muhcu) – Raced three wide without cover throughout. Bumped with Gee Gee Acehigh on jumping.

Gee Gee Als Prince (T Baker) –Crowded, bumped heavily and became unbalanced when Seguimientos shifted outward entering the home straight.

Recompensa (M Ulucinar) - Rider reported that the saddle slipped at the 1000 metre mark.

Gee Gee Ladybird (S So) – Had to be continually steadied off the heels of runners in front approaching the 800 metres.

Seguimientos (G Catania) – Stewards found G Catania guilty of a charge under AR 131(a) for careless riding the particulars being that entering the home straight, she took a run where there was insufficient room. This resulted in her mount making heavy contact with Gee Gee Als Prince, which became unbalanced. After taking into account her submissions on penalty, her good record, and the mid-range level of the carelessness, Stewards suspended her licence for 1 race date (date to be advised).

GENERAL

Stewards inquired into tactics adopted on Pop A Honda at the Tasmanian Turf Club meeting on the 6th of October 2021. T Baker stated that the gelding was fractious in the barrier and then it had been slow to begin, raced back in the field and commenced to over race. He received some pressure approaching

the home turn and had to steady his mount. He had also been held up entering straight and had to shift wide to obtain a clear run. After that he rode out under hands and heels, being mindful that he had ridden it at its first start and when placed under pressure with the whip had not responded. Stewards noted his comments.
