Approaching the first turn Max Bandit and Wynburn Joy bumped. On the first turn Max Bandit and Playboy Danger bumped, checking both greyhounds. Entering the home straight Playboy Danger checked off the heels of Snake Ivy. King Kingo tired over the concluding stages. Approaching the winning post, Playboy Danger and Wynburn Joy bumped. Yaramundi Hoover underwent a post race veterinary examination and was found to have spike wounds and an abrasion to its left hind paw and mild neck soreness. Yaramundi Hoover has been stood down from racing for a period of 7 days.

A pre race swab sample was taken from Little Lexi. Soon after the start Fire Flick and Cripps bumped. In the back straight Little Lexi and Meg Bee bumped. On the first turn Voodoo Girl and Chasing Issac bumped, checking both greyhounds. On the home turn Voodoo Girl and Little Lexi bumped. Chasing Issac underwent a post race veterinary examination and no apparent injury could be detected. A post race swab sample was taken from Meg Bee, the winner of the event. Stewards spoke to Trainer Mr L Nichols in relation to Chasing Issac’s race manners in the home straight. Acting on their own observations, viewing the official replays and taking evidence off Mr Nichols, Stewards were of the opinion that although Chasing Issac’s head was more off centre in the home straight, Stewards could not be satisfied that Chasing Issac had turned its head inwards which constitutes failing to pursue and as a result took no further action against this greyhound.
