SUPPLEMENTARY

DEVONPORT TRIALS – Tuesday 23rd November 2021

Heat 3:

Stewards questioned rider E Byrne-Burke (MEL SAID) regarding an incident passing the 700 metres where MEL SAID lost ground when racing to the inside of WELDBOROUGH (P Lui). After questioning riders and viewing the vision of the trial Stewards preferred a charge of careless riding under ARR 131 (a) against Apprentice Lui. The particulars being that Apprentice Lui permitted WELDBOROUGH to shift ground inward when not clear of MEL SAID, which was checked. After consideration Apprentice Lui's licence to ride in races was suspended from the conclusion of racing on Wednesday 8th December 2021, up to and including racing on Wednesday 15th December 2021 (1 race meeting)

TASMANIAN TURF CLUB – Wednesday 1st December 2021.

Race 1: Transmo Anything /Anywhere/Anytime Maiden (1,400 metres)

Stewards concluded an investigation into an incident near the 1,000 metres where SCAREDEE and CANDY CRUSHER were checked when racing to the inside of SPECIAL GUEST (P Lui) which shifted in. After questioning riders and reviewing vision of the incident Stewards charged Apprentice Lui with a breach of ARR 131(a). The particulars being that Apprentice Lui permitted SPECIAL GUEST to shift in when not clear of SCAREDEE. Apprentice Lui admitted the breach. After consideration Apprentice Lui's licence to ride in races was suspended from the conclusion of racing on Wednesday 15th December 2021, up to and including racing on Sunday 19th December 2021 (1 race meeting)

TASMANIAN TURF CLUB – Wednesday 1st December 2021.

Race 4: McB Developments Pty 3YO Cup (1,200 metres)

Stewards concluded an investigation where, rounding the final turn, MAJESTIC DIAMOND (E Byrne-Burke) became awkwardly placed near the heels of TURF WARRIOR (I Toker) which shifted inward to a position adjacent to rail. After consideration I Toker was severely reprimanded under ARR 131 (a) and firmly reminded of his obligations when shifting ground.

GENERAL

Medical certificate received from Apprentice T Stalker

Race 1 - GOODSTONE GROUP MAIDEN - 1009 metres

ENSNARE- hampered at start; failed to make the first turn correctly when hanging out; continued to hang for the remainder; warning placed on racing manners.

DADORABLE – ran out when steadied off heels passing the 650 metres; again, steadied off heels passing 500 metres when the tempo eased.

GEE GEES BUZZ – began awkwardly and lost ground.

I'M KRUIPT – tightened after the start and got back.

FAIRY FLING – shifted out on jumping and bumped.

LACERATE – raced wide throughout.

WAYNES DELIGHT – jumped out at start and bumped heavily.

ETOSHA- raced wide throughout.

MEIGETSU – hampered at start; not persevered with over final stages, finishing well back; rider questioned- felt indifferent in actions; veterinary check revealed no abnormalities; must trial before next racing.

Race 2 – CARLTON & UNITED BREWERIES CLASS 1 Hcp 1150 metres

FAR AWAY HIT- shifted out on jumping and lost ground; over-raced early and middle stages; held up passing 500 metres and taken wider to improve.

REBEL FACTOR – held passing the 400 metres; denied marginal run passing 250 metres and taken wider to improve.

MADETOBEBROKEN – rider reported indifferent in actions- veterinary check revealed the gelding to be mildly dehydrated.

Race 3 – BIRDCAGE TAVERN & FUNCTION CENTRE BENCHMARK 68 HCP - 1150 metres

SIRENE STRYKER – inclined to lay in through the final straight.

Race 4 – THAI IMPERIAL BENCHMARK 62 HCP - 1650 metres

DUNMINING was a late scratching at 3:33pm after sustaining an injury enroute to the meeting. Trainer Mr J Keys was advised that a veterinary clearance would be required prior to the mare next racing.

GREGORIAN CHANT- lay in throughout the final straight and passing the 75 metres shifted in, having to be straightened, losing momentum in consequence.

SUBMIT ANOTHER – rider reported respiratory noise on pulling up- veterinary check revealed no abnormality. Trainer advised to monitor recovery and advise any relevant outcome.

Following the event Apprentice J Curtain (GREGORIAN CHANT), in the presence of her employer, was shown vision of the final stages of the race for instructional purposes.

Race 5 – LADBROKES GOLDEN MILE HCP 1650 metres

BANCA NIP – fractious in the barriers and began awkwardly, getting back; held up in early stages of final straight; taken wider 200 metres to improve.

UP WIND – began awkwardly.

WHITE HAWK – travelled three-wide throughout; trainer questioned regarding improved performance.

Stewards questioned trainer Mrs A Brakey regarding the improved performance of winner WHITE HAWK. In explanation Mrs Brakey stated that WHITE HAWK was inclined to mix his performances, however had pleased in training prior to today. The explanation was noted.

Race 6 – TASMANIAN HORSE TRANSPORT 0-60 RATING - 1150 metres

CALINGO – slow in the early stages.

TILTHEREWASYOU- lay in over final stages.

TIDAL – lay in throughout the final straight.

When questioned regarding the performance of

Race 7 – KEVIN SHARKIE CLASS 1 HCP - 1350 metres

NEED A FLUTTER – tightened at start and got back; travelled wide through middle stages.

CHOSEN EAGLE- jumped in abruptly at the start. Hung out rounding turns; veterinary check revealed no abnormality.

HERMAN'S BELLS – held up rounding final turn.

GEE GEE RHYTHM – held up passing 200 metres; raced in restricted room final stages.

Race 8 - LENDING 4 U BENCHMARK 62 HCP - 1350 metres

ISKRA - raced wide in early stages
