#### SUPPLEMENTARY

##### **TASMANIAN TURF CLUB – Wednesday 8<sup>th</sup> December 2021**

##### **Race 2 – TRANSMO ANYTHING/ANYWHERE/ANYTIME MAIDEN (1200 METRES)**

Trainer Mr D Tyson has advised that after returning to his stables, SCARDIMALIA had been displaying muscle soreness in the rump region, as well being shin sore. Mr Tyson advised that SCARDIMALIA will now be spelled.

##### **Race 1 - CRESSY CHAFF CUTTERS JIM OSBORNE LONGFORD CUP MAIDEN (1200M)**

The start of this race was delayed 1 minute 45 seconds due to the reins on **KATZENJAMMER** having to be replaced.

Apprentice Miss T Johnstone was dislodged from GEE GEE ENUF SPEED enroute to the barriers, however, was uninjured.

**UPSET** – got its head up when being steadied passing the 900 metres and shifted out; held up passing 400 metres; laid in over final stages.

**BUNDY CHASER** – rider questioned regarding performance

**BE KINDER** – slow in the early stages.

**FOUR LETTER WORD** – bounded on jumping rider reported tongue over the bit.

**GEE GEE ENUF SPEED** – laid in near 900 metres and bumped.

**KATZENJAMMER** – tightened passing the 900 metres and lost ground.

**Ms V Medhurst**, representing trainer Mr A Duggan, admitted a breach of Rule 206 (1) and was fined \$200.00 for presenting KATZENJAMMER to race in unapproved gear (buckle reins)

### **Race 2 – WWW.CRESSYCHAFFCUTTERS.COM.AU CLASS 1 HCP (1200M)**

**TILTHEREWARSYOU** – escaped from the barriers after being loaded away and travelled an excessive distance before being recaptured. The mare was declared a late scratching at 6:05pm. Trainer L Gray was advised that **TILTHEREWARSYOU** must trial to the satisfaction of the Stewards before racing next.

**GEE GEE ALS PRINCE** – jumped awkwardly and got back.

**SILENT DREAMER** - bumped at start and unbalanced, shifted out abruptly and bumped; over-raced middle stages.

**BONDI TIFF** – badly hampered after start and got back.

**PEACE BE UPON HIM** – travelled 4-wide throughout; rider questioned; after racing wide had little left when pressured; veterinary examination revealed no abnormality.

**BELLE CADEAU** – badly hampered after start and lost ground; shifted out abruptly to obtain clear running passing the 100 metres; became awkward near heels final 50 metres and unable to be fully tested.

### **Race 3 – CRESSY CHAFF CUTTERS FOR ALL YOUR LUCERNE BM76 HCP (1200M)**

**GEE GEE TRUE STORY** – held up rounding the final turn; checked near 100 metres.

**VIVILICI** – hampered near 900 metres

**GEE GEE QUEEN BEE** – raced ungenerously passing 900 metres.

**RED LETTER LADY** – tightened and checked passing the 400 metres; held up rounding final turn; taken wide passing 300 metres to obtain clear running.

**GEE GEE LANET** -travelled wide throughout.

**SCOTTISH PRINCE** – post-race veterinary check revealed suffering from dehydration.

Ms **S Carr** (GEE GEE TRUE STORY) admitted a breach of ARR 131 (a) with the particulars being that passing the 400 metres she permitted her mount to shift in when not clear of RED LETTER LADY which was tightened and checked. After consideration Ms Carr's licence to ride in races was suspended from the conclusion of racing on Wednesday 22<sup>nd</sup> December 2021 up to and including racing on Wednesday 29<sup>th</sup> December 2021. (One riding day)

Rider **A Darmanin** (MISS CHARLIE BROWN) admitted a breach of ARR 131 (a) with the particulars being that passing the 100 metres he permitted his mount to shift inwards and into the running of RED LETTER LADY which was checked. After consideration Mr Darmanin's licence to ride in races was suspended from the close of racing on Wednesday 22<sup>nd</sup> December 2021 up to an including racing on Saturday 1<sup>st</sup> January 2022.

#### **Race 4 – CRESSY CHAFF CUTTERS FOR ALL YOUR OATEN CLASS 1 HCP (1600M)**

**BELMISTA** – held up passing the 400 metres until near the 200 metres.

**EVELINA ROSE** – began awkwardly becoming unbalanced- shifted and bumped heavily.

**GOOD LUCK BOB** – held up rounding the final turn; obtained clear running 200 metres; raced in restricted room final 50 metres.

**HEZA CHARMER** – slow to begin

**PERKINS** – travelled wide throughout.

#### **Race 5 – CRESSY CHAFF CUTTERS FOR ALL YOUR RED CLOVER CLASS 3 HCP (1400M)**

**HUON CHIEF**- dropped rider transiting to the barriers; must trial; raced wide in early stages; hampered passing 400 metres and dictated wider.

**LADY** – steadied off heels passing 700 metres.

**SAN YOU** – travelled 3-wide throughout.

**STEFANIDI** – slow to begin; held up passing 500 metres; raced in restricted room passing 100 metres.

Rider **A Darmanin** was severely reprimanded under the provisions of Rule 131 (a) after permitting his mount to shift out near the 400 metres and bumping heavily with HUON CHIEF which was taken wider on the track.

#### **Race 6 – STEVE'S LIQUOR 3YO TROPHY (1400M)**

**ALPINE WOLF** – steadied passing the 800 metres when awkwardly on heels.

**RICH CLAN** - over-raced passing the 1,000 metres.

#### **Race 7 – RAYNER TRANSPORT CONQUERING STAKES CONQUERING STAKE (1400M)**

**I'M WESLEY** -raced wide in the early stages; over-raced middle stages; rider questioned- failed to respond when pressured; post-race veterinary check revealed suffering from dehydration.

**MANDELA EFFECT** – held up rounding the final turn until obtaining clear running passing the 200 metres.

**AMAWORD** - post-race veterinary examination of revealed the gelding to be suffering from a holosystolic heart murmur. Trainer Ms T Keys was advised that a veterinary clearance, including a satisfactory cardiac ultrasound, would be required prior to AMAWORD next racing.

**Race 8 – CRESSY CHAFF CUTTERS FOR A RANGE OF LOW SUGAR CHAFF BM62 HCP (1200M)**

**DEBRIEF** – became unbalanced and shifted out when making the turn near the 800 metres.

**GEE GEE JOSIE** – travelled 3-wide throughout.

**SEGUIMIENTOS** – travelled keenly passing the 600 metres

**SIDOROVA** – held up rounding final turn until near 250 metres.

**Race 9 - CRESSY CHAFF CUTTERS FOR ALL YOUR ROLLED GRAINS BM76 HCP (200M)**

**OVERPLAY** – lay out and bumped passing the 50 metres.

**THE RISK FACTOR** – lay in from the 1,000 metres; lay in and bumped passing the 50 metres becoming briefly unbalanced.

Mr G Stevenson, trainer of the second placed OVERPLAY viewed the vision of the final stages with respect to considering a protest against first placed THE RISK FACTOR, however elected not to proceed.
