Lucky Lynn underwent a post race veterinary examination and was found to have a graze to its right toe however no stand down period was issued.

The start of this event was delayed by 2 minutes when a false start was affected by the Starter when Buckle Up Wilder backed out of the boxes due to the lid not being fully closed. As a result the box lids did not open upon the lure reaching starting point. All greyhounds underwent veterinary examinations and were passed fit to start. Buckle Up Wilder and Combat Mission were slow out. Approaching the first turn Bridwood Tyson and She's It bumped, checking She's It, Combat Mission and Bridwood Bella. Approaching the home turn Hawk Danger and Buckle Up Wilder bumped. She's It and Bridwood Bella raced wide around the home turn. Stewards spoke to owner Mrs R Johnson in relation to Buckle Up Wilder box manners in this event. Acting on their own observations, viewing the official replays and taking evidence off Starter Ms A Norgrove, Stewards deemed Buckle Up Wider difficult to box and ordered that the greyhound be box first in future events.

Adrianna completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on 22nd March 2021 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 28.3 kilograms and beginning from box 1, Adrianna completed the 515 metre trial distance in a time of 30.64. Adrianna has been cleared to race all tracks.

Enchanted Spirit completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on 29th November 2021 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 32.9 kilograms and beginning from box 5, Enchanted Spirit completed the 515 metre trial distance in a time of 30.35. Enchanted Spirit has been cleared to race all tracks.

Dewana Magoo completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on 5th July 2021 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 32.7 kilograms and beginning from box 7, Dewana Magoo completed the 515 metre trial distance in a time of 30.09. Dewana Magoo has been cleared to race all tracks.

Winklee Hugo completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on 5th July 2021 for failing to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Weighing 36.6 kilograms and beginning from box 3, Winklee Hugo completed the 515 metre trial distance in a time of 30.56. Winklee Hugo has not been cleared as the greyhound eased in the back straight and as a result did not perform to the satisfaction of Stewards.
