RACE 1 – CROWN LAGER – AUSTRALIA’S BEST – GRADE 6 (1) – 452M

Soon after the start Wild Charlie stumbled. At the same time Mono’s Bear and Xavier’s Blue bumped. In the back straight Mono’s Bear and Xavier’s Blue bumped. On the first turn Contour and Mono’s Bear bumped, checking Mono’s Bear and Wild Charlie. Approaching the home turn Xavier’s Blue checked off the heels of Tah Tracey. On the home turn Contour marred the running of Tah Tracey. Mono’s Bear underwent a post race veterinary examination and was found to have a spike wound to its left paw. Mono’s Bear has been stood down from racing for a period of 3 days. Contour underwent a post race veterinary examination and no apparent injury could be detected. Stewards spoke to Trainer Mr M Stringer in relation to Contour’s race manners around the home turn. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Contour turned his head outwards towards Tah Tracey and made head or muzzle contact with that greyhounds on 2 occasions and by doing so has marred the running of that greyhound pursuant to GAR 69(1). Acting under the provision of GAR 69(2)(a), Contour has been stood down from racing for a period of 28 days Devonport only and until the completion of a satisfactory trial.

At the same time Bleak Midwinter, Blue Pelle and White Poison bumped. A post race swab sample was taken from Bleak Midwinter, the winner of the event.

Soon after the start Twiggy Stick, On The Beers and Hiccup Gus bumped, checking Twiggy Stick and On The Beers. In the back straight Masani Bale and Rissa’s Girl bumped, checking Rissa’s Girl. In the home straight Masani Bale eased. Masani Bale underwent a post race veterinary examination and was found to have soreness to its right back muscle. Masani Bale has been stood down from racing for a period of 10 days. Miss Comet underwent a post race veterinary examination and was found to have mild back soreness. Miss Comet has been stood down from racing for a period of 10 days. Stewards spoke with Trainer Mr P Hili in relation to Masani Bale’s race manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Masani Bale had eased in the home straight and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR 69B(1)(a). Masani Bale has been stood down from until the completion of a satisfactory trial.
