A pre race swab sample was taken from Meg Bee. Stewards spoke with Trainer Mr P Cassidy in relation to the race manners of Meg Bee entering the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Meg Bee had briefly turned its head inwards towards a bird on the inside of the track and then momentarily shied. After giving due consideration to the circumstances, stewards elected to take no action against Meg Bee.
