Races 2 – 8 were abandoned due to a State-wide data outage affecting all of Tasmania. After waiting until 3.00pm for rectification, Stewards elected to abandon the meeting at this point.

Due to the delay in being able to review the official replays because of the data outage, Stewards later spoke with Trainer, Ms Loretta McShane in relation to You're Off's race manners in the home straight. Where, in the opinion of stewards, You're Off had turned its head inwards toward Magic Rogue and by doing so, had failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). However, given the delay on the day, Ms McShane had left the course and consequently, You're Off was unable to be checked by the on-track veterinarian. Given this, no charge was laid by the stewards. A warning, however, was placed on the greyhound's race manners and, Ms McShane was told, that stewards will closely monitor You're Off's manners in future events.
