Acting on their own observations and viewing the official replays, Stewards were of the opinion that Agent Meatball had eased in the back straight and by doing so had failed to pursue the lure with due commitment throughout the event, pursuant to GAR 69A(1). Acting under the provisions of GAR 69A(2)(a), Agent Meatball has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial. Wynburn Calypso underwent a post-race veterinary examination, and no apparent injury could be detected.
