## **GENERAL**

Trainer Mr A Bullock presented Langley Roo for kennelling with the incorrect registration papers. Mr Bullock was fined the sum of \$50.00 pursuant to GAR 33(4) as this was his second offence within the three-month turnaround period.

Stewards spoke to Trainer Mr L Nichols in relation to his technique when boxing greyhounds.

Recall completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on the 29<sup>th</sup> of November 2021 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR 69B(1)(a). Weighing 34.8 kilograms and beginning from box 5, Recall completed the 340-metre trial distance in a time of 19.50. Recall has been cleared to race at all tracks except Launceston up to the distance of 340 meters.
