Recall completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on the 29th of November 2021 for failing to pursue the lure with due commitment throughout the event by reason of injury pursuant to GAR69B(1)(a). Weighing 35.1 kilograms and beginning from box 5, Recall completed the 515-metre trial distance in a time of 29.84. Recall has been cleared to race at all tracks. Recall underwent a post-race veterinary examination and was found to have soreness in left tensor fascia. Recall has been stood down from racing for a period of 14 days.
