A pre race swab sample was taken from Never Sweat. Major Look underwent a post race veterinary examination and no apparent injury could be detected. Family Spark underwent a post race veterinary examination after falling in the catching pen and was found to have minor skin grazes on its left wrist however no stand down period was issued. Stewards spoke to Trainer Mrs D Cannan in relation to Major Look’s racing manners in the home straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Major Look had turned its head outwards towards Never Sweat however failed to make head or muzzle contact but by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR 69A(1). Acting under the provisions of GAR 69(2)(a), Major Look has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial.
