***Comments / Explanations:*** G Catania was transported to hospital after being dislodged from Lion Academy in Race 2. She will require a medical clearance before she rides track work, trials, or races.

**RACE 1 – LEIGH JORDAN ONE AGENCY COLLINS REAL ESTATE BM68 HCP - (1650 METRES)**

Correct weight was delayed when G Catania Rider of Shampz Again lodged a protest against Incriminate alleging interference near the 200m. It was established that passing the 150m Incriminate which had layed out shifted back in when insufficiently clear of Shampz Again, which had to be checked. After taking submissions from all parties and viewing the official films, stewards were not satisfied that the interference exceeded the margin at the end of the race (2 Lengths) and the protest was dismissed. An inquiry into the interference has been adjourned subject to the availability of G Catania.

**ROCK THE BOWLER** – Jumped awkwardly and slow to begin.

**SHAMPZ AGAIN** – Checked when crowded by Incriminate passing the 150m.

**INCRIMINATE** – Shifted out near the 200m before being corrected and shifting back in when not clear of Shampz Again.

**GEEGEE'S FIRST LADY** – Jumped awkwardly. Tired over the concluding stages. S Carr reported the mare did not respond to her riding.

**RACE 2 – LADBROKES MATES MODE MAIDEN - (1009 METRES)**

**LION ACADEMY** – A warning has been placed on the gelding's barrier manners, for rearing prior to the start. Shied and shifted in abruptly near the 100m and dislodged the rider. G Catania was transported to hospital for precautionary x-rays. Lion Academy has been stood down to an official trial for its racing manners.

**ANJERO** – Jumped awkwardly and raced wide throughout.

**LIONROUND** – Raced wide throughout.

**ROCK'EM BABY** – Layed out rounding the 600m turn.

**BOLD INSTINCT** – A warning has been placed on the barrier manners of the gelding for rearing prior to the start.

**GEEGEE'S TONIC** – Raced wide throughout.

**STARNOTE** – Layed in near the 300m.

**MISS ENTHUSIASM** – Declared a late scratching prior to racing commencing at 10.30am as there was no available rider.

### **RACE 3 – GOODSTONE GROUP MAIDEN - (1350 METRES)**

**URAGUAY** – Raced wide throughout.

**EGAO** – Over raced and caught wide until the 900m.

**EIGHT MARGARITAS** – Shifted in under pressure approaching the winning post.

**GOLD GOWN** – A post-race veterinary examination revealed no abnormalities.

**RUNS LIKE WATER** – Fractious in the barrier. A post-race veterinary examination revealed blood in the left nostril from an external trauma.

**SHAMMGOD (NZ)** – Over raced in the early and middle stages. Held up for a clear run from the 500m to the 300m and layed in near the 100m.

**SILVER PERSUASION** – Raced wide throughout.

**GEEGEE'S HISWORD** – Jumped inwards at the start and layed in near the 100m.

### **RACE 4 –TASMANIAN HORSE TRANSPORT MDN/CL1 – (1650 METRES)**

**BELMISTA** – Broke through gates after Namabaale became fractious and cast, declared late scratching on veterinary advice after striking its head.

All bets on Belmista are to be refunded in full with the following deductions were ordered:

1<sup>st</sup> Port Berry 29c for the win 44c the place.

2<sup>nd</sup> Sweetsop 38c the place.

3<sup>rd</sup> Big John 20c the place.

**MAINCOURT**– Shifted out abruptly on jumping.

**NAMABAALÉ** – Became fractious and cast in the barriers. Declared a late scratching at 1.41pm veterinary advice. Namabaale must trial prior to being permitted to race again. The gelding was lame in the near hind, a veterinary clearance will be required before trialling or racing.

All bets on Namabaale are to be refunded in full with the following deductions were ordered:

1<sup>st</sup> Port Berry 29c for the win 44c the place.

2<sup>nd</sup> Sweetsop 38c the place.

3<sup>rd</sup> Big John 20c the place.

**BIG JOHN** – Hampered on jumping. Layed in near the 100m bumping with Vamp.

**PORT BERRY**–. When questioned on the apparent improved performance today Trainer J Blacker stated that the reduced field due to the three late scratching's and the placement and way she was ridden in today's race contributed to her winning performance.

**SWEET STOP** – Checked at the start when Maincourt shifted out.

**CLOUD CHASER** – Declared a late scratching at 12.10pm as there was no available rider.

All bets on Cloud Chaser are to be refunded in full with the following deductions were ordered:

1<sup>st</sup> Port Berry 25c for the win 41c the place.

2<sup>nd</sup> Sweetsop 30c the place.

3<sup>rd</sup> Big John 17c the place.

**RUNNING IN CIRCLES** – Tired home turn. A post-race veterinary examination revealed a slow recovery rate.

#### **RACE 5 – THAI IMPERIAL CLASS 1 HCP - (1150 METRES)**

**LORD WHITEGATE** – Over raced approaching the 600m turn.

**DAWN EAGLE** – Rider reported after being caught wide the filly failed to respond to her riding and she felt there may have been something amiss with its action. A post-race veterinary examination revealed a slow recovery rate.

**SILENT DREAMER** – Over raced approaching the 600m turn.

**QUEEN'S THE WORD** – Slow to begin.

**DADORABLE** – Layed in under pressure over the concluding stages.

**BAHEERA**– Declared a late scratching as there was no available rider.

#### **RACE 6 – LENDING 4 U BM76 HCP (1150 METRES)**

**ANCONA** – Jumped awkwardly and was slow to begin. When questioned D Ganderton reported that he felt there may have been something amiss with the gelding. A post-race veterinary examination revealed that both front plates had been lost in running. Upon review of the race it was noted that this occurred after entering the home straight.

**ARTUSO** – Raced wide throughout.

**JULIUS** - Blundered on jumping.

**REWARD ACHIEVER** - Over raced in the middle stages.

#### **RACE 7 –GREAT NORTHERN 0-62- (1009 METRES)**

**ETOSHA** – Jumped awkwardly, raced three wide without cover throughout. Tired over the concluding stages. When questioned on the below market expectation performance C Baker stated the colt had worked hard early from a wide barrier and this had taken its toll over the concluding stages. A post-race veterinary examination revealed no abnormalities.

**TROJAN STORM** – Slow to begin.

**RHYME WRITER** – Bumped on jumping when Etosha shifted in.

**TERRACOTTA (NZ)** – Hung in under pressure approaching the winning post.

## **RACE 8 –KEVIN SHARKIE BM68 HCP (1350 METRES)**

**RAISING HSIANG** – Layed in under pressure in the home straight.

**FREELANCER** – Rider D Ganderton pleaded guilty to a charge under AR 132(7)(a)(ii) in that he used his whip on 6 occasions prior to the 100m. Taking into account his guilty plea, excellent record under the rule and the low level of the breach he was fined \$200. \$100 of which is to be suspended unless he reoffends in the next three months.

**IMAGINE HOWE** – A post-race veterinary examination revealed no abnormalities.

**HOT RELATION** - Raced three wide in the early and middle stages.

**LADY JOKER** – Shifted out at the start bumping with So I'm Dreaming.

**SO I'M DREAMING** – Inconvenienced at the start when Lady Joker shifted out. Over raced in the early stages. Held up for a run from the 400m to the 300m and layed in over the concluding stages.

**SKILENDRA** – Slow to begin.

## **RACE 9 –YOUNG RACING TASMANIA BM62 HCP (1880 METRES)**

**GREGORIAN CHANT (NZ)** – Carried wider on the home turn by Dramazing which had improved to the outside of Geegees Rock Opera.

**DRAMAZING** – Held up for a clear run approaching the 500m. Layed in over the concluding stages.

**ALWAYS A WINNER** - Over raced in the early stages.

### **GENERAL**

All race times were put back one race after Race 2 due to delays caused when G Catania required transfer to hospital in Burnie. The last event was then programmed to be run at 4.30pm.
