Miss Lexi underwent a post-race veterinary examination which revealed the greyhound to have grazes on the right hind paw however, no stand down period was applied. Stewards spoke to Trainer Ms C Nash in relation to the race manners of Miss Lexi in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Ms C Nash, stewards were of the opinion that Miss Lexi had turned its head outward towards Rivergum Sal and in doing, so failed to pursue the lure with due commitment throughout the event pursuant to GAR124. Acting under the provisions of GAR127(b) Miss Lexi has been stood down from racing for a period of 28 days at all tracks and until the completion of a satisfactory trial.
