Stewards spoke to Trainer Mr P Hall in relation to the race manners of Benny Bound in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr P Hall, stewards were of the opinion that Benny Bound had turned its head inwards towards Winklee River and in doing so failed to pursue the lure with due commitment throughout the event pursuant to GAR 124(1). Acting under the provisions of GAR 127(a) Benny Bound has been stood down from racing for a period of 28 days at Launceston only and, until the completion of a satisfactory trial. A post-race swab sample was taken from Wynburn Skye, the winner of the event.

Acting on their own observations, viewing the official replays and taking evidence from Mr Bullock, stewards ascertained that as a result of bumping heavily with Buckle Up Adalyn in the home straight, Hypnotize was checked and as a consequence, the greyhound gave ground over the concluding stages and did not ease. Stewards spoke to trainer Mr S Gerrard in the relation to My Name's Joe being difficult to load, acting on their own observations, viewing the official replays and taking evidence from Mr Gerrard. Stewards placed a warning on My Name's Joe.
