Stewards spoke to Trainer Mr J Barwick in relation to Smoking Yogi's race manners approaching the winning post. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Smoking Yogi turned its head inwards towards Loves Again but failed to make head or muzzle contact but by doing so, had failed to pursue the lure with due commitment throughout the event pursuant to GAR 124. Acting under the provisions of GAR 127(a), Smoking Yogi has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial. A post race swab sample was taken from Circles, who was unplaced in the event.
