Acting on their own observations and viewing the official replays, Stewards were of the opinion that Maddie's Help turned its head outwards towards Highland Wonder but failed to make head or muzzle contact but, by doing so, had failed to pursue the lure with due commitment throughout the event pursuant to GAR124. Acting under the provisions of GAR127(a), Maddie's Help has been stood down from racing for a period of 28 days Launceston only and until the completion of a satisfactory trial.
