Stewards spoke to Trainer Mr J Wilton in relation to the race manners of Marry The Night in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr J Wilton, stewards were of the opinion that Marry The Night had eased approaching the winning post and in doing so, had failed to pursue the lure with due commitment throughout the event pursuant to GAR 124(1). Acting under the provisions of GAR 127(a) Marry The Night has been stood down from racing for a period of 28 days at Devonport @ Hobart only and, until the completion of a satisfactory trial. A post-race swab sample was taken from Lektra Linda.

Weighing 32.3 kilograms and beginning from box 3, Quest For More completed the 461-metre trial distance in a time of 26.10. Quest For More has been cleared to race at all tracks except Shepparton up to 461 metres.

Maddie’s Help completed a Stewards satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on 27/06/2022 for Failing to pursue pursuant to GAR124(1).
