A pre-race swab sample was taken from Outright. Benny Bound underwent a post-race veterinary examination, and no injury could be detected. Stewards spoke to trainer Mr P Hall in relation to the racing manners of Benny Bound in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Hall. Stewards were of the opinion, that Benny Bound had visibly eased free of interference approaching the winning post and in doing so had failed to pursue the lure with due commitment throughout the event, pursuant to GAR124. Acting under the provisions of GAR127(b), Benny Bound has been stood down from racing for a period of 28 days at all tracks and until the completion of a satisfactory trial. Tiny Turtle underwent a post-race veterinary examination and no was found to have had sprained toes on the left foreleg. Tiny Turtle has been stood down from racing for a period of 21 days. Stewards spoke to trainer Mr A Bullock in relation to Tiny Turtle's racing manners in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Bullock. Stewards were of the opinion, that Tiny Turtle had turned its head inwards and had made head and muzzle contact with Rivergum Belle, and by doing so had marred the

running of that greyhound pursuant to GAR123. Acting under the provisions of GAR127(a), Tiny Turtle has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial.
