Dashing Pippa has been stood down from racing for a period of 6 days. Sticker Sells underwent a post-race veterinary examination and no injury could be detected. Stewards spoke to Trainer representative Mr M Sherriff who had already left the track in relation to Sticker Sells race manners in the back straight. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Sticker Sells eased, and by doing so had failed to pursue the lure with due commitment throughout the event pursuant to GAR124. Acting under the provisions of GAR127(a), Sticker Sells has been stood down from racing for a period of 28 days Hobart only and until the completion of a satisfactory trial.
