Comments / Explanations:

Rider S Carr provided a medical clearance to ride at today's meeting.

RACE 1 – KEVIN SHARKIE 3YO MAIDEN - (1150 METRES)

BORN A WINNER – Rider reported the gelding resented racing back in the field. Accidentally dropped whip near the 200 metres.

GEEGEE'S SUNSHINE – Bumped with MADJACK at the start. Over raced in the early stages. Rider T Johnstone dropped her whip near the 150 metres.

MADJACK – Bumped on jumping.

MIGHTYMAXI – Jumped awkwardly and was slow to begin, failed to muster early speed, tailed the field throughout. Rider reported the gelding resented the kick back and raced very greenly. A post-race veterinary examination revealed no obvious abnormalities. A warning was placed on the gelding's racing manners.

ROYAL AND TOUGH – Jumped awkwardly, over raced in the early and middle stages. Held up for a clear run on the home turn.

SHARMA'S LAST – Raced wide throughout.

ROYAL MOLLY – Hung out throughout.

RACE 2 – TASMANIAN HORSE TRANSPORT CLASS 1 HCP - (1150 METRES)

PROPHET EYES – Raced wide throughout.

STRATISFACTION – Over raced near the 600 metres shifted out carrying STATUE OF DREAMS wider. Rider E Byrne-Burke reported that the gelding resented the kick back when entering the home straight and failed to respond to her riding.

FEISTY LION – Rider M Ulucinar was reprimanded under the provisions of AR131(a) careless riding for crossing STATUE OF DREAMS near the 900 metres when not clear.

QUICKEN UP – Laid out under pressure near the 200 metres.

STATUE OF DREAMS – Stewards granted permission for rider B Neto to ride 0.5kg over the allotted minimum weight. Carried wider near the 600 metres when STRATISFACTION commenced to over race and shifted out. Steadied near the 900 metres when tightened by FIESTY LION which was not fully clear.

RACE 3 – LADBROKES EASY FORM MAIDEN - (1350 METRES)

DUNCANNON – Over raced in the early stages. Held up entering the home straight. Not ridden out from the 100 metres. When questioned rider reported the horse pulled hard and hung in from the home turn. A post-race veterinary examination revealed no obvious abnormalities. Stewards adjourned an inquiry into the tactics adopted today.

GOOGA THE GOAT – Stood flat footed and missed the start by a considerable distance. Must trial prior to racing again.

HEWIE – Held up on the home turn and entering the home straight, then obliged to shift wider.

NO ACCESS – Shifted in over the last 100 metres and made contact with TENNESSEE BEACH just prior to the winning post.

RIGHT HOOK – Rider D Parish was reminded of her obligations to ensure she rides her mount out fully to the line, under the provisions of AR131b.

TENNESSEE BEACH – Bumped at the winning post when NO ACCESS shifted in. Over raced early stages of the race.

OUR INDULGENCE – Over-raced in the early and middle stages.

GEEGEELOCKDOWN – Caught wide early stages.

RACE 4 – GOODSTONE GROUP MAIDEN/CLASS 1 - (1650 METRES)

HELLFIRE EAGLE – Bumped by LUCE DE LA LUNA near the 1300 metres.

BAHEERA – Raced three wide throughout, shifted out near the 200 metres, bumped by GEE GEES ENUF SPEED near the 50 metres.

GEE GEE ENUF SPEED – Team Wells were fined \$100 under the provisions of AR206(2) for a late gear change adding blinkers. Shifted in approaching the winning post and bumped with BAHEERA.

PAGE – Slow to begin.

TOUGH COOKIE – Jumped awkwardly.

HAMPTON STREET – Raced wide from the 1000 metres.

LISKAMM – Steadied off heels near the 1300 metres.

LUCE DELLA LUNA – Over raced approaching the 1300 metres.

RACE 5 – GREAT NORTHERN BM60 HCP - (1880 METRES)

ASHMANIA – Rider stated when questioned on the below market expectations performance that the mare travelled well but hung out. She was held up for a run on the home turn and was on the wrong leg until entering the home straight.

MAINCOURT – Shifted wider to obtain a position closer to the lead passing the 1600 metres.

GEEGEEES ROCK OPERA – Carried wider at the 1600 metres when MAINCOURT shifted out.

HIGH MAINTENANCE – Checked after the start between EIGHT MARGARITAS and ASHMANIA both of whom shifted ground.

EIGHT MARGARITAS –Bumped soon after the start.

CAPTAIN DAVE – Raced wide throughout.

CAPTAIN MORGAN(NZ) – Slow to begin.

RACE 6 – ROBYN CLARKE MEMORIAL BM68 HCP - (1150 METRES)

MISS TUPPENCE –Inconvenienced on jumping when DONTBUCMEOFF shifted out. Rider reported when questioned

DON'TBUCKMEOFF – When questioned on the disappointing performance today rider A Darmanin reported he felt something amiss with its action. A post-race veterinary examination revealed there to be a restriction in the off fore fetlock. A veterinary certificate will be required before trialling or racing again.

GEEGEELUCKYSTAR – Raced wide throughout.

TILTHEREWARSYOU – Compounded from the home turn. Rider reported that the mare was breathing abnormally from the 400 metres. A post-race veterinary examination revealed the mare had suffered Atrial Fibrillation. Stewards have directed that TILTHEREWARSYOU must complete a 1000 metre gallop and have a veterinary clearance with the result of an ECG before trialling or racing again.

RACE 7 – THAI IMPERIAL 0- 60 - (1350 METRES)

MULTISANTI – Raced ungenerously throughout.

GEE GEE CAN WIN –Slow to begin.

RHYME WRITER – Steadied off heels near the 1200 metres.

MILITARY LAW –Slow to begin. Checked off heels near the 1200 metres when placed in restricted room by Herman's Bells whose rider was placed at a disadvantage by her saddle slipping.

HERMAN'S BELLS – Rider C Baker reported that the saddle slipped soon after the start placing the rider at a disadvantage throughout.

LUCA BRATZI - Slow to begin.

RACE 8 – FIGHT MND BM68 HANDICAP - (1350 METRES)

ANCONA – Slow to begin, over raced and compounded over the concluding stages. Stewards questioned rider D Ganderton on the poor performance of the gelding. Rider D Ganderton stated that he was disappointed on the performance and that the gelding did lunge at the barrier gates on opening, and he settled back further back than he anticipated. And that he was at a loss and unable to add anything further. A post-race veterinary examination revealed no abnormalities.

LESNAR – Brushed with AZARA near the 50 metres.

ALPINE BLAST – Over raced middle stages of the race.

GEE GEES JENNIA – Slow to begin.

GENERAL

DEVONPORT RACE MEETING 28/8/2022

RACE 6 BIRDCAGE TAVERN BM 68 HCP

Stewards concluded an inquiry into the tactics adopted by riders T Johnstone (DARGO) and E Byrne Burke (IRISH SHOTGUN) which resulted in both horses leading the main body of the field after working forward due to the slow pace. Stewards accepted the explanations tendered that the tactics were consistent with previous runs. However, both riders were advised that they may have erred in not allowing their mounts some respite in the middle stages. Stewards also added they must ensure they don't ride their mounts in a manner open to query.

RACE 9 THE GREAT NORTHERN BENCHMARK 60 HCP

Stewards issued Taylor Johnstone with a reprimand under AR 131(a) for careless riding for shifting wider on the home turn making heavy contact with THE EXECUTIVE and carrying that gelding wider on the track.
