A pre-race swab sample was taken from Buckle Up Lila. Buckle Up Lila underwent a post-race veterinary examination and was found to be sore in the left hind tensor fascia. Buckle Up Lila has been stood down from racing for a period of ten days. Stewards spoke with Trainers representative Mrs R Johnson in relation to the race manners of Buckle Up Lila. Acting on their own observations and viewing the official replays, Stewards were of the opinion that Buckle Up Lila had eased when approaching the first turn, and by doing so had failed to pursue the lure with due commitment throughout the event by reason of injury, pursuant to GAR125(1)(a). Buckle Up Lila has been stood down from racing for a period of ten days and until the completion of a satisfactory trial.

GENERAL

Big Red Ruby completed a steward's satisfactory trial as it was stood down from the Launceston Greyhound Racing Club meeting on the 29th of October 2022 for marring pursuant to GAR123. Weighing 29.9 kilograms and beginning from box 5, Big Red Ruby completed the 515-metre trial distance in a time of 30.42. Big Red Ruby has been cleared to race all tracks.

Summertime Sad completed a steward's satisfactory trial as it was stood down from the Hobart Greyhound Racing Club meeting on the 20th of October 2022 for failing to pursue the lure by reason of injury pursuant to GAR125(1)(a). Weighing 26.3 kilograms and beginning from box 3, Summertime Sad completed the 278-metre trial distance in a time of 16.80. Although finishing outside of the qualifying time, Stewards deemed the trial satisfactory due to the interference the greyhound sustained. Summertime Sad has been cleared to race all tracks except Hobart and up to 278 metres only.

Border Star completed a steward's satisfactory trial as it hasn't started in an event for in excess of six months pursuant to GAR135. Weighing 25.7 kilograms and beginning from box 3, Border Star completed the 278-metre trial distance in a time of 16.51. Border Star has been cleared to race all tracks
