Comments / Explanations:

Trainers' explanations for late rider declarations were accepted.

RACE 1 – EXAMINER NEWSPAPER MAIDEN (1200M)

FROLAND – Very fractious in the barriers and withdrawn from the gates. Underwent a pre-race veterinary examination and was passed suitable to start. Trainer G McCulloch was advised that the gelding would be required to barrier trial prior to racing again.

GOES LIKE THE WIND – Raced fiercely in the early and middle stages. Near the 800m had to be restrained and shifted wider to avoid heels.

LADY SARAH – Raced three wide throughout.

BELLASARIO – Proved very difficult to load and kicked out striking a barrier attendant. Trainer J Blacker was advised that the filly would be required to trial prior to racing again. A post-race veterinary examination revealed no abnormalities. When questioned on tonight's performance S Carr explained that she felt that something

was amiss with the filly's action over the concluding stages. S Carr was reprimanded under AR114(2)(a) in that she failed to report after the race something which might have affected the running of her horse.

SNOWBIRD – Laid out throughout. Ran wider making the home turn.

OUR SATURDAY – Stood flatfooted in the barriers and failed to jump with the field. Trainer L Gray was advised that the gelding would be required to trial prior to racing again.

ELLE OF A BREEZE – Hampered and steadied off the heels of HATHAWAY on the home turn when attempting to take a tight run. Upon inquiry it was established that a run had momentarily presented for I Toker but he had not been able to take advantage of it due to HATHAWAY rolling in marginally. A Darmanin was advised to exercise care when his mounts shift ground. I Toker was also advised to ensure there is adequate room to progress in similar circumstances.

RACE 2 – BURNIE NEWAGENCY MAIDEN (1400M)

AUSSIE BLACK – Raced three wide throughout.

COUP DE SPRY- Bucked shortly after the start and took no further competitive part. Trainer L Gray was advised that gelding would be required to trial prior to racing again.

MILLA'S READY – Held up rounding the home turn and again when approaching the 100m when POET WARRIOR rolled in marginally.

THREE'S A CROWD- Raced three wide and without cover in the early stages. Performed below market expectations. Apprentice C Jordan explained that the mare failed to quicken when placed under pressure and in her opinion will be better suited over more distance.

RACE 3 – CHARLES ST NEWSAGENCY CLASS 1 HCP (1400M)

NOZTRABEEL- Over raced in the middle stages. Jockey B Muchu advised that the gelding changed legs and became unbalanced near the 600m. He further added that the gelding was not suited by the tempo set throughout.

BYNANCE – Held up for a clear run rounding the home turn.

POWERFUL PEBBLES- Slow to begin. Over raced in the early and middle stages.

SHAMZOU- Raced wide and without cover throughout.

BAHEERA- Near the 200m was obliged to shift out from the heels of NAMABAAL to obtain clear running. Apprentice T Johnstone reported that it was her intention to be further forward however after being beaten for speed early she settled further back than anticipated. Trainer G McCulloch confirmed that it was his instruction for the mare to take up a forward position.

RACE 4 – LONGFORD NEWSAGENCY OPEN HCP (1400M)

SH'BOURNE REBEL- Stewards acceded to a request from the trainer for B McCoull to ride the gelding 1kg over the allotted weight of 56kgs.

LUCKY LIL- Slow into stride.

RACE 5 – INVERMAY NEWSAGENCY 3YO HCP (1100M)

JAGUAR STONE – Hampered at the start.

BOLD INSTINCT – Began awkwardly and shifted out hampering JAGUAR STONE.

BOKEO- Raced three wide in the early stages. A post-race veterinary examination revealed no abnormalities.

FULL ZULU- Beaten in excess of 18 lengths. A post-race veterinary examination revealed no abnormalities. Trainer G McCulloch was advised that a warning would be placed on the performance of the gelding.

RACE 6 – BRISBANE ST NEWS & LOTTO CLASS 3 HCP (1100M)

VETLANDA Began awkwardly. In the early part of the home straight was momentarily held up behind the tiring TITLE SHOT.

TITLE SHOT- Raced fiercely throughout. Performed below expectations. Apprentice C Jordan explained the mare raced very fiercely in the middle stages despite her efforts to ease the pace, however she was content with the tempo set. She further added that when she placed the mare under pressure rounding the home turn, the mare failed to respond and was very disappointing. A post-race veterinary examination revealed the mare to have a poor post-race recovery rate.

RACE 7 – RIVERSIDE POST, NEWS & LOTTO BM68 HCP (1600M)

UP WIND – Slow to begin. Over raced near the 1200m.

STEEL SKIES – Began awkwardly. Rider D Pires advised that in his opinion the gelding would appreciate racing over further distance.

WELDBOROUGH – Began awkwardly and shifted in making contact with STEEL SKIES.

JOHN'S LAD – Raced three wide throughout.

RACE 8 –NEXTRA KINGS MEADOWS NEWSAGENCY BM60 HCP (1200M)

TWEE – Shifted in on jumping. T Baker reported the mare laid in throughout.

LORD WHITEGATE - Held up rounding the home turn. A post-race veterinary examination revealed no abnormalities. Rider A Darmanin was found guilty of a charge under AR131(b) in that he failed to ride his mount out over the final three strides, which

in the opinion of the stewards, cost his mount second place, the margin being a nose. A Darmanin's licence to ride in races was suspended for a period of 1 Tasmanian Race Date to commence at the expiration of a suspension incurred at Bendigo on 26 October 2022, which expires Midnight 11 November 2022. This suspension will then commence and expire at Midnight 13 November. In considering penalty stewards were mindful of A Darmanin's good record in relation to this rule however his inaction had cost his mount second place.

WHEELING- Shifted out on jumping.

STEER FOR LADY- Hampered on jumping. Raced three wide throughout. Rider G Catania reported that she felt something amiss with the mare in the home straight. A post-race veterinary examination revealed no obvious abnormalities.
