2022, for failing to pursue, pursuant to GAR124(1). Weighing 28.9 kilograms and beginning from box 3, Rojo McGee completed the 278-metre trial distance in a time of 22.25. As the greyhound failed to make the qualifying time, Rojo McGee has not been cleared to race.
