Xanadu underwent a post-race veterinary examination, and no apparent injury could be detected. Stewards spoke to trainer Mr R Ransley in relation to Xanadu's racing manners, in particular shortly after jumping in the back straight. Acting on their own observations, viewing the official replays, and taking evidence from Mr Ransley. Stewards were of the opinion, that Xanadu had turned its head inwards and had made head and muzzle contact with Blitz Danger, and by doing so had marred the running of that greyhound pursuant to GAR123. Acting under the provisions of GAR127(b), Xanadu has been stood down from racing for a period of 28 days at all tracks, and until the completion of a satisfactory trial. Nitro Harvey underwent a post-race veterinary examination and was found to have mild abrasions to the dorsal surface of the left hind paw, however no stand down period was applied. no apparent injury could be detected.
