### **GENERAL**

Allan Coe completed a stewards' trial over the 278-metre trial distance pursuant to GAR130 for cramping on 14<sup>th</sup> of September 2022 at the Taralgon Greyhound Racing Club meeting. Weighing 34.7 kilograms and beginning from box 3. Allan Coe completed the 278-metre trial distance in a time of 16.26. After undergoing a post-trial veterinary examination, the greyhound showed no signs of cramping. Allan Coe has been cleared to race at all tracks.

Zurhaar completed a stewards' trial over the 515-metre trial distance pursuant to GAR124 for failing to pursue on the 5<sup>th</sup> of December 2022 at the Launceston Greyhound Racing Club meeting. Weighing 31.5 kilograms and beginning from box 5. Zurhaar completed the 515-metre trial distance in a time of 30.09. Zurhaar has been cleared to race at all tracks up to 515m except Launceston, until his suspension expires on the 1<sup>st</sup> of January 2023.
