### Comments / Explanations:

Trainer S Brunton was fined the sum of \$100 for late rider declarations under the provisions of LR13.3 for Race 3 MOVE LIKE JAGGER and Race 4 BANCA GLEE.

### RACE 1 – LEIGH JORDAN ONE AGENCY REAL ESTATE MAIDEN - (1,350 METRES)

**ALMIGHTY VIRTUE** – Slow to begin, rider T Doyle dropped his whip passing the 200 metres.

**KATZENJAMMER** – Rider T Johnstone was harmlessly dislodged on returning to the mounting yard.

**GOTCHAGOOD** – Over-raced in the early stages.

**KREGLINGER** – Was declared a late scratching at 12.30pm after being fractious behind barriers then reared in barriers striking its head. Trainer A Trinder was advised that the gelding will be required to trial satisfactorily, and a veterinary clearance provided, prior to racing again. On the announcement of correct weight Stewards ordered that all monies invested on KREGLINGER to be refunded, with the following deductions to apply to successful wagers placed prior to 12.30pm.

Deductions

(1 <sup>st</sup> ) Katzenjammer –	24 cents a win & 15 cents a place
(2 <sup>nd</sup> ) Almighty Virtue –	37 cents a place

All monies bet after the withdrawal to be paid at face value of the ticket.

**GEE GEES FLYBY** – Eased down over the final stages of the race displaying soreness in the near foreleg. A post race veterinary examination confirmed the mare to be lame in the left fore. Trainer S Gandy was advised a veterinary clearance was required prior to the mare's next race. Stewards to follow up with Trainer S Gandy on the mare's progress.

### **RACE 2 – CARLENE COBBING MEMORIAL BM62 HCP - (1,200 METRES)**

**KAYTEE VALIENTE** – A post race veterinary examination failed to reveal any abnormalities.

**IMAGINE HOWE** – Began awkwardly.

**TRUE SCOTSMAN (NZ)** – Tongue tie replaced behind barriers prior to start, bounded on jumping and settled back in the field, made the turn at the 600 metres awkwardly then held up passing the 250 metres and taken wider on the track.

**ANONYMOUS SOURCE** – Brushed inside barrier on jumping, laid in near the 200 metres rider C Baker stopped riding to straighten her mount.

**OLYMPIC HONOUR** – Bounded on jumping.

**HAS THE LOOK** – Underwent a pre-race veterinary examination due to a haematoma in the pectoral region and was passed fit to race. Trainer N Schuurin reported that the mare was found to be in season on returning to the mounting yard.

### **RACE 3 – DEAN WALKER DESIGNS MAIDEN – (1,009 METRES)**

**LYCALLEGRO** – Jumped awkwardly and restrained shortly after the start. Rider C Wells was advised to exercise more care when allowing her mount to shift in over the concluding stages.

**MOVE LIKE JAGGER** – Jumped awkwardly.

**FLYING BILLIE** – Over raced early and middle stages.

**GEE GEES CHORIS** – Adjusted tongue tie at the barriers.

**BELLASARIO** – Jumped awkwardly and was slow to begin, bumped heavily with DEPASSER after the start then over raced in the early and middle stages.

**ROYAL MOLLY** – Rider D Parish reported something amiss with the filly's action. A post race veterinary examination revealed lameness in the right hind leg. Trainer M Trinder was advised a veterinary clearance was required prior to the fillies next race start.

#### **RACE 4 – WINNING EDGE PRESENTATIONS MDN/CL1 – (1,880 METRES)**

**COUP DE SPRY** – Over raced in the early and middle stages.

**GOOD LUCK BOB** – Raced wide throughout.

**POET WARRIOR** – Raced up onto heels near the 1,000 metres.

**ANDITWASTHEBEST** – A post race veterinary examination failed to reveal any abnormalities.

**BANCA GLEE** – Jumped out at the start then over raced in the early stages.

**SPECIAL INTEREST** – Bumped with ARTFUL PEGASUS at the start.

**ARTFUL PEGASUS** – Shifted in abruptly at the start bumping with SPECIAL INTEREST.

**FRYER HILL** – Raced wide throughout.

**WANING WEASEL** – Stewards granted permission for rider B Neto to ride 1kg over the allotted weight. Was hampered after the start.

**YOUR SHUFFLE** – Raced three-wide until the 800 metres.

#### **RACE 5 – BEACH CLUB CLASS 1 HCP – (1,150 METRES)**

**TASPINARO** – Brushed with SNOWBIRD after the start.

**RIGHT HOOK** – Raced wide throughout.

**MADETOBEBROKEN** – Slow to begin, settled at the rear of the field, disappointed for a run early in the home straight before shifting wider to obtain clear running.

**LABBY ROCK** – Raced wide throughout, underwent a post-race veterinary examination which failed to reveal any abnormalities

**SNOWBIRD** – Underwent a pre-race veterinary examination at the request of the trainer and was found to have an abrasion to the near hind hock and was passed fit to race. Shifted out on jumping and brushed with TASPINARO, underwent a postrace veterinary examination which revealed no abnormalities.

### **RACE 6 – LADBROKES CARPET CHARGE – (1,009 METRES)**

**GEE GEE SECONDOVER** – Shifted in after the start.

**LIFFEYBEAU** – Rider D Parish was reminded to exercise more care when shifting in when not fully clear of GALENUS approaching the 700 metres.

**TURK WARRIOR** – over raced in the early stages.

**GALENUS** – Hampered shortly after the start. Steadied by its rider approaching the 700 metres when racing to the inside of LIFFEYBEAU. Stewards questioned rider G Catania on the below market performance of the gelding. Rider G Catania stated that the gelding travelled well but when placed under pressure failed to respond to her riding.

### **RACE 7 – KEVIN SHARKIE BM64 HCP – (1,150 METRES)**

**RING OF HONOUR** – Raced wide throughout.

**ALPINE AFFAIR** – Crowded shortly after the start, settled back.

**LUCKY BUCKY** – Shifted out after the start, over raced early then eased down over the concluding stages. Underwent a post-race veterinary examination which failed to reveal any abnormalities. Trainer K Maskiell advised the gelding would now be retired.

**GEE GEE ALS PRINCE** – Hampered after the start losing ground, shifted out under pressure over the final 50 metres.

**POWER MAGNUM** – Slow to begin.

**TILTHEREWARSYOU** – Raced wide throughout. A warning was continued on the mare for being fractious in the barriers. Rider M Ulucinar reported the mare was making unusual respiratory noises. A post-race veterinary examination revealed the mare to have a sore back.

### **RACE 8 – LADBROKES DEVONPORT CUP – (1880 METRES)**

**WHITE HAWK** – Raced wide throughout

**ALPINE WOLF** – Began awkwardly with rider briefly becoming unbalanced.

**SH'BOURNE RENEGADE** – Crowded after the start then got back.

**RISING LIGHT** – Raced wide throughout.

**VALLABAR** – Tightened and checked at about the 300 metres.

**DRAMAZING** – Tightened, checked, and became unbalanced near the 300 metres.

**MAINCOURT** – Stewards granted permission for rider B Neto to ride 1kg over the allotted minimum, Raced wide throughout.

**ARGYLE BEACH** – Rider T Baker pleaded guilty to a charge of careless riding under the provisions of AR131(a), the careless riding being that near the 300 metres, he permitted his mount to shift out when not sufficiently clear of VALLABAR (T Johnstone), resulting in that mare being tightened and checked and DRAMAZING (A Darmanin) to the outside being tightened and becoming unbalanced and losing its position.

Rider T Baker was suspended for a three Tasmanian race dates commencing midnight 13<sup>th</sup> January, 2023 until midnight 21<sup>st</sup> January, 2023. In assessing penalty, Stewards took into account his guilty plea, excellent record and that the carelessness was in the low to mid-range.

**RACE 9 – CARLTON & UNITED BREWERIES BM62 HCP – (1350 METRES)**

**ASPIRATE** – Slow to begin. Checked rounding the home turn when GEE GEE CAN WIN had a tendency to lay in at the same time MASCHERATA was placed awkwardly on the heels of the tiring MISS SLEUTH.

**MASCHERATA (NZ)** – Placed awkwardly on the heels of the tiring MISS SLEUTH rounding the home turn.

**GEE GEE CAN WIN** – Had a tendency to lay in rounding the home turn. Rider B McCoull advised stewards that the gelding raced erratically in the home straight.

**SPIRITED TOFF** – Was declared a late scratching at 5.14pm after it reared in the barriers striking its head. Trainer M Trinder was advised that the gelding will be required to trial satisfactorily prior to racing again and veterinary clearance would be required. On the announcement of correct weight stewards ordered that all monies invested on SPIRITED TOFF to be refunded, with the following deductions to apply to successful wagers placed prior to 5.14pm.

Deductions

(1st) - GEE GEE CAN WIN –	6 cents a win & 6 cents a place
(2nd) - ALPINE BLAST –	10 cents a place
(3 <sup>rd</sup> ) – WILLBY RULES –	11 cents a place

All monies bet after the withdrawal to be paid at face value of the ticket.

**MISS SLEUTH** – Commenced to tire from the 300 metres and laid out on the home turn. Stewards queried the tactics adopted on the mare. Rider C Wells stated that after jumping better than expected and gaining a handy position early it was her intentions to allow the horse to settle in the run. Stewards noted her comments.
