Curly's Crusade was declared a late scratching at 11.27am on veterinary advice, after a pre-kennelling veterinary examination revealed a torn monkey muscle on the right foreleg. Curly's Crusade has been stood down from racing for a period of 28 days. Stewards spoke to trainer Mr E Howard in relation to Mighty Night's racing manners, in particular in the home straight. Acting on their own observations, viewing the official replays and taking evidence from Mr Howard, Stewards were of the opinion that Mighty Night had turned its head inwards and had made head and muzzle contact with Daisy Danger in the home straight, and by doing so had marred the running of that greyhound pursuant to GAR123. Acting under the provisions of GAR127(a), Mighty Night has been stood down from racing for a period of 28 days at Launceston only and until the completion of a satisfactory trial.
