RACE 1 - YOUNG GROUP PACE – 2090 METRES

NOVA BAXTER pulled hard at various stages during this event.

RACE 2 – RACING CONNECT PACE – 2090 METRES

MAJOR GENERALJUJON caught wide early, before progressing to a position outside the leader.

LETSPLAYUNI utilised the sprint lane.

IDEN BLACK PRINCE utilised the sprint lane.

COOL SCOOTER NZ shifted out under pressure over the concluding stages.

RACE 3 – PRYDES EASIFEED PACE – 2090 METRES

IDEN SIRE FRANKIE broke shortly after the start. This colt has been placed outside the draw in future mobile start events.

NEON broke free of interference as the field raced out of the home straight on the first occasion. This colt has been stood down until the completion of a satisfactory trial.

SOUTHER LUCK has been placed back in the draw for future mobile start events.

RACE 4 – NUTRIEN SPRINTLANE PACE – 2090 METRES

KARALTA ARTEMIS broke during the score up, causing a false start, this gelding has been placed outside the draw in future mobile start events. KARALTA ARTEMIS broke free of interference in the home straight as a consequence this gelding has been placed on its last chance to race truly.

SHARMEY utilised the print lane.

LORIMER LADY utilised the sprint lane.

The all clear for this event was delayed allowing Stewards to view the official films of the concluding stages. After viewing the official films and acting on their own observations Stewards were satisfied that KARALTA ARTEMIS had been immediately restrained by its driver and had not gained any ground while galloping. The all clear was given on the judge's numbers.

RACE 5 – LEIS FILLIES AND MARES SERIES – 2090 METRES

CEE TEE CHELSEA hung in as the field approached the home turn on the final occasion before breaking free of interference. BOBBIE ADDISON who was racing in a trailing position contacted the sulky of KARALTA ARTEMIS and as a consequence galloped and fell. CEE TEE CHELSEA has been placed on its last chance to race truly.

BOBBIE ADDISON underwent a post-race veterinary examination that revealed no apparent injuries.

RACE 6 – MORE CONFIDENCE COSULTING PACE – 2090 METRES

BLUE LABEL broke as the field was released for this event slightly inconveniencing ISOLATION. As a consequence, BLUE LABEL has been placed outside the draw in future mobile start events.

BOSTON BUSKER caught wide in the early stages before being restrained to the rear of the field.

The all clear for this event was delayed allowing Stewards to view the official films of the start. After viewing the films and acting on their own observations Stewards were satisfied that BLUE LABEL had broken simultaneously with Starter Mr. Adam Emery releasing the field. All clear was given on the judge's numbers.

RACE 7 – CAVALOR EQUICARE PACE – 2090 METRES

EQUITY STRIDE caught wide during the early stages of this event before being restrained to the rear of the field.

MICKEY OH caught wide during the early stages of this event before being restrained to the rear of the field.

VINNY CHASE Stewards gave permission [AHRH 158(1)] for Olivia Weidenbach replaced driver Tim Yole who was indisposed due to illness.

Driver Mathew Howlett was advised to modify his whip action to avoid any future sanctions under relevant whip rules.

RACE 8 – TASMANIAN HORSE TRANSPORT PACE – 1609 METRES

NOOSA BEACH jibbed when coming out of the circle prior to the start of this event, locking wheels with MACH ANGELO. NOOSA BEACH has been placed on its last chance in the mobile start draw.

KENYA NZ caught wide early and restrained to the rear of the field.

CHEDDAR VALLEY NZ was out of position at the start and will continue to be placed outside the draw in future mobile start events.

HERES HENRY utilised the sprint lane.

LORIMERTYRRELL shifted out under pressure over the concluding stages.

The all clear for this event was delayed allowing driver Jordan Chibnall (BRIAN WHO) the opportunity to view the official films of the concluding stages of this event. After viewing the official films, driver Jordan Chibnall elected not to proceed any further and all clear was given on the judge's numbers.

Driver Tiarna FORD (LORIMERTYRRELL) pleaded guilty to a charge under [AHRH 162(1) (www)(b)] in that she allowed her drive to shift out over the concluding stages hindering the running of BRIAN WHO. After considering the circumstances and severity of the breach in addition to her relatively good record under this rule Stewards issued a reprimand.

RACE 9 – CLUBS TASMANIA PACE – 2597 METRES
