Comments / Explanations:

Rider D Pires was indisposed for this meeting due to a trackwork incident during the week. Rider D Pires has been advised that a medical clearance will be required prior to riding again.

RACE 1 – LADBROKE IT! MAIDEN – (1200 METRES)

Correct weight was delayed due to rider F Kersley (GEEGEEHAILSTORM) wishing to view the official patrol films of the home straight. After viewing the footage, Mr Kersley was satisfied and correct weight was declared on the judge's numbers.

CAPTAIN CAM – Commenced to buck shortly after the start and shifted in, causing BLOOM TIME and LONTANO to be carried inside the false rail. Trainer R Hamer was advised that the gelding would be required to trial prior to racing again due to its racing manners.

LONTANO – Clipped the heels of TULATI at about the 200 metres and blundered.

MANDATE – Shifted out rounding the home turn, bumping GEEGEEHAILSTORM.

STREETS AHEAD – Tightened between FOREIGN LEGION and LOVE NEST shortly after the start. Had a tendency to over race in the early stages.

BLOOMTIME – Shifted in at about the 200 metres, resulting in TULATI being checked by its rider.

GEEGEEHAILSTORM – Carried wider by MANDATE rounding the home turn.

LITTLE RIVER TOFF – Had a tendency to over race between the 1000 metres and 800 metres. Rider S Carr reported she had difficulty with the filly's race manners.

THEM'S THE BREAKS – Underwent a pre-race veterinary examination which revealed no abnormalities. Raced wide throughout.

TULATI – Checked severely just prior to the 200 metres by BLOOMTIME. Underwent a post-race veterinary examination which revealed the filly to be mildly lame in the near hind. Trainer J Bazen was advised a veterinary clearance would be required prior to the filly racing or trialling again.

Rider A Darmanin (BLOOMTIME) pleaded guilty to a charge of Careless Riding under the provisions of AR131(a) the particulars of the charge were that at about the 200 metres he allowed his mount to shift in when insufficiently clear of TULATI (T Baker). Which had to be checked by its rider. Rider A Darmanin's licence to ride in races was suspended for 1 Tasmanian race date commencing midnight 15th March, 2024 and ending 22nd March, 2024. Rider A Darmanin was advised of his right of appeal.

RACE 2 – GOOD FRIDAY FAMILY FUN DAY 29TH MARCH MAIDEN - (1400 METRES)

LET'S MESSAROUND – Inconvenienced at the start when MYSTIC HOPE shifted in and AUNTY JAKE'S BAR shifted out. Shifted in abruptly when resenting the whip at about the 150 metres.

MILTON – Shifted out under pressure in the concluding stages.

MYSTIC HOPE – Jumped inwards at the start.

SURELY SPECIAL – Fractious in the barriers. Over raced in the early stages. Jumped out at the start, bumping with AUNTY JAKE'S BAR, causing that horse to shift outwards. Had a tendency to hang in throughout the home straight.

PEPPARONI – Jumped outwards at the start.

PURPLE MOON – Bounded on jumping.

RICH'N'POWERFUL – Raced wide throughout.

YOU BETTER RUN – Underwent a post-race veterinary examination which revealed no obvious abnormalities.

AUNTIE JAKE'S BAR – Underwent a post-race veterinary examination which revealed no obvious abnormalities.

RACE 3 – LADBROKES SPORTS BAR MAIDEN - (1400 METRES)

GEEGEE'S SUNSHINE – Inconvenienced by TRABZON on jumping.

MAY WE ALL – Raced three wide during the middle stages.

TRABZON – Shifted out on jumping, inconveniencing GEEGEE'S SUNSHINE. Brushed with GODDESS OF ROCK just prior to the winning post.

BORNATMEWAH – Bumped with MISS VIVACE when entering the home straight.

PONSFORD – Had a tendency to over race in the early stages.

MISS VIVACE – Bumped with BORNATMEWAH when entering the home straight.

ELEGANTLY WRITTEN – Raced three wide.

GODDESS OF ROCK – Brushed with TRABZON just prior to the winning post.

LULULAND – Over raced throughout the early stages.

RACE 4 – TASBREEDERS NIGHT 5TH APRIL MAIDEN/CLASS 1 - (1600 METRES)

CAPTAIN TAZ (NZ) – Jumped outwards at the start bumping with ZULU ESPRIT, which then inconvenienced GEEGEE'S TIGERLILLY.

LYCALLEGRO – Bounded at the start. Had a tendency to over race in the early stages.

ZULU ESPRIT – Had a tendency to over race in the early stages.

PREWINGO – Over raced in the early stages. Raced three wide throughout.

RACE 5 – THE ART HOTEL LAUNCESTON CLASS 1 HANDICAP – (1400 METRES)

ASVA (NZ) – Brushed with DAQUARI DIVA shortly after the start. Shifted in slightly in the home straight, causing DAYAN STAR to shift in around the 200 metres.

DAYAN STAR – Carried in by AVSA (NZ) at around the 200 metres.

GEEGEE'S DOWN SOUTH –

DAIQUIRI DIVA – Brushed with AVSA (NZ) shortly after the start. Checked in the home straight between DAYAN STAR and ROHZHAE.

EMMJAY (NZ) – Over raced early stages, raced wide throughout.

NOXIOUS – Stewards granted permission for rider M Ulucinar to ride ½ kilogram over the allotted weight. Began awkwardly, raced three wide throughout.

FLIGHT READY – Over raced in the early stages.

RACE 6 – BATTLE OF THE BANDS FRIDAY 22ND MARCH BENCHMARK 60 HANDICAP – (1400 METRES)

SWEET LUCIFER – Over raced throughout.

LION'S TOOTH – Commenced to race ungenerously near the 800 metres.

BELLUNA – Had a tendency to over race in the middle stages.

BORN A WINNER – Reared and bounded on jumping, causing apprentice T Johnstone to lose her balance. Had a tendency to over race in the early and middle stages.

AMANCAYA – Raced wide throughout.

BOUNTY BAY – Had a tendency to over race in the middle stages.

A LITTLE DECEIT – Shifted out abruptly approaching the 200 metres, causing the gelding to momentarily lose its footing behind.

RACE 7 – KEVIN SHARKIE CLASS 2 HANDICAP – (1200 METRES)

SUSHI EXPRESS – Brushed the inside running rail momentarily before checking off the heels of MYOCARDIUM when entering the home straight, when improving and looking for a clear run.

HEAD'EM – Slow to muster early speed.

CHEROKEE DANCER – Bumped by SHARE THE GOLD on jumping.

LA FOLIE DOUCE – Raced three wide throughout. Underwent a post-race veterinary examination which revealed no obvious abnormalities.

SHIM – Over raced in the middle stages.

MR FREEZE – Over raced throughout.

PUNK PRINCESS – Over raced in the early stages. Underwent a post-race veterinary examination which revealed no obvious abnormalities.

SHARE THE GOLD – Jumped out at the start bumping with CHEROKEE DANCER. Approaching the winning post was tightened for racing room between MR FREEZE and CHEROKEE DANCER.

RACE 8 – STEVE'S LIQUOR BENCHMARK 68 HANDICAP – (1600 METRES)

SQUARE DONUT – Raced wide throughout.

OLE OLA – Had a tendency to over race in the early and middle stages. When questioned on the below market expectations, rider D Ganderton stated that the mare had been difficult over racing throughout and being caught wide in the early stages had not helped today. He also added that in his opinion the mare may have come to the end of its preparation. Trainer G Stevenson advised that the mare would now be spelled. Underwent a post-race veterinary examination which revealed no abnormalities.

ZULU ANGEL – Over raced in the early and middle stages.

DID YOU DECIDE – Slow to begin. Had a tendency to over race in the early stages.

ALPINE BLAST – Raced wide in the middle stages.

KITTY PURRING – Apprentice C Baker reported that she had ridden the mare conservatively today as it had a previous tendency to over-race.

RACE 9 – LAUNCESTON'S BIGGEST EASTER EGG GOOD FRIDAY BENCHMARK 60 HANDICAP – (1100 METRES)

INTISAR – Contacted the outside the outside barrier gate on jumping. Inconvenienced by CHAMPAGNE CINDERS when that filly was pushed outwards at the start. Bumped with FIESTY LION shortly after the start.

ETOSHA – Jumped in at the start. Shifted out on the home turn carrying CHAMPAGNE CINDERS wider, Apprentice C Van Munster was advised to exercise care in similar circumstances.

CHAMPAGNE CINDERS – Bumped by WHEELING at the start, shifting the filly outwards inconveniencing INTISAR. Carried wider rounding the home turn by ETOSHA and had to steady off that gelding's heels.

WHEELING – Jumped outwards at the start, contacting CHAMPAGNE CINDERS and pushing that filly out onto INTISAR.

FIESTY LION – Blundered at the start and was slow to begin, bumped with INTISAR shortly after the start. Trailed the field throughout and took no competitive part.

Correct weight was delayed due to apprentice C Baker wishing to view the official patrol films of the home turn. After viewing the footage, Miss Baker was satisfied and correct weight was given on the judges numbers.

ADDENDUM

DEVONPORT RACE CLUB – TRIALS – 12th MARCH, 2024

Trainer A Trinder advised stewards that his gelding INCRIMINATE had bled from both nostrils on returning to his stables. Mr Trinder was advised that under the provisions of AR79(4), the gelding would be stood down from racing or trialling for a period of three months and following that time will be required to complete a 1000 metre gallop in the presence of stewards.

TASMANIAN TURF CLUB – 28th FEBRUARY, 2024

RACE 10 – THE CITY OF LAUNCESTON CLASS 1 HANDICAP (1400 METRES)

Rider F Kersley (DAYAN STAR) pleaded guilty to a charge of Careless Riding under the provisions of AR131(a). The particulars of that charge being that at about the 100 metres, he allowed his mount to shift inwards, and continued to ride his mount out vigorously after receiving pressure momentarily to his outside from SIR JAG (K Sanderson), which had shifted in slightly. This resulted in FLIGHT READY (C Newitt) being severely checked and losing its rightful running.

Rider F Kersley was suspended for One Tasmanian race date and was reminded of his right of appeal.

The Steward's report as posted is provisional and subject to further review and amendment.
