SUNDAY- 5<sup>TH</sup> MAY 2024 - Ladbrokes Park Elwick. Race 8. -

Driver K Williams was reminded of his obligations in regard to leaving the course without the permission from the Stewards.

**General:**

Stewards undertook random drug testing of drivers at tonight's race meeting.

Stewards approved the following driving changes due to driver R Walters failing to provide a urine sample as directed by Stewards:

### **RACE 1 – PACING FOR PINK STAKES – 1680M MOBILE**

SOKYS LINE- Contacted marker pegs and the driver was reminded of his obligations.  
SWIMINTHERIVER NZ- Pre-race swab sample taken. Hung inwards and contacted marker pegs.  
Held up for a clear run in the early stages of the home straight.

### **RACE 2 – LADBROKES RACING CLUB STAKES – 1680M MOBILE**

I WANT IT ALL NZ- Pre-race swab sample taken. Placed in restricted room at the 1400m.  
NIL DESPERANDUM- Broke free of interference and was placed on its last chance to race truly.  
Held up for a clear run in the early part of the home straight.  
HERAKLES- Post-race swab sample taken.  
HEZ A FAKE- Hung out despite the efforts of the driver and was placed on its last chance to race truly.  
ALBERIO- Severely checked shortly after the start.  
CHRIS BE QUICK- Severely checked shortly after the start.  
MY ULTIMATE ROMEO- Inconvenienced after the start.  
ROCK ON PLAYBOY- Inconvenienced after the start.  
RANIERI NZ- Hung in and contacted marker pegs. Held up for a clear run in the home straight.

Stewards questioned drivers Dylan Ford (I WANT IT ALL NZ) and Lachlan Dakin (HEZ A FAKE) into reasons why Dylan Ford was placed in restricted room at the 1400m causing his nearside wheel to track inside a number of marker pegs. After taking evidence from both drivers and viewing the official patrol films it was established that HEZ A FAKE was-not tractable when asked to move to a peg line position by its driver, resulting in the geldings head trailing the helmet of the horse directly in front for a distance, however its body hung out into the one wide line. Then near the 1400 metres, as I WANT IT ALL NZ was improving on the peg line, HEZ A FAKE then shifted in, placing I WANT IT ALL NZ in restricted racing room. Stewards were satisfied that HEZ A FAKE'S manners were the main contributing factor in this incident. HEZ A FAKE has been placed on its last chance to race truly.

### **RACE 3 – HAPPY MOTHERS DAY PACE – 1680M MOBILE**

The start of this race was delayed 5 minutes due to race7 Kalgoorlie thoroughbred meeting running late.

OCTAGONISE- Hung in and contacted marker pegs. Momentarily inconvenienced in running in the home straight.  
NANCYS HOPE- Showed gate speed to lead the event. Raced greenly then shied resulting in the gelding shifting outwards in the home straight on the first occasion.

NOBLEZZZ ADVICE- Caught wide early and restrained to the rear. Hung inwards and contacted marker pegs.

OBLER- Momentarily inconvenienced in the home straight.

LUNCHTIME LASS- Post-race swab sample taken.

KIWI TILLY- Held up for a clear run in the early stages of the home straight.

IDEN KAMAKAZI- Revert to ODM from RODM.

#### **RACE 4 – TRAINER ENCOURAGEMENT SERIES HEAT ONE – 2200M MOBILE**

JILLIBY MENDOZA- Post-race swab sample taken.

NAPATTACK SAM- Broke after the start and was placed out of the draw in future mobile events. Hung inwards and contacted marker pegs.

SOUTHERN LUCK- Caught wide early and progressed forward to gain the position outside the leader leaving the back straight to receive the bell.

KENS CHIPS- Was out of position at the start despite the driver's efforts and will be placed on its last chance in the draw.

ROYAL REACTOR- Pre-race blood sample taken.

SWEET AMOUR- Checked at the start due to a galloping runner.

SHOOIN- Inconvenienced at the start due to the galloping runner.

Following an Inquiry, driver Dylan Ford, pleaded guilty to a charge under provisions of rule AHRR168(1)(e), improper driving, in that while NAPATTACK SAM was galloping shortly after the start, he used his reins, sawing the bit through NAPATTACK SAM's mouth, in an attempt to bring the gelding back to its correct gait. Stewards took into consideration Dylan Ford's previous record in relation to this offence, the circumstances that were put forward by Mr Ford, the perceived severity of the sawing action, previous penalty precedents and his guilty plea. Dylan Ford was fined a sum of \$350.00 and advised of his obligations in this situation for future reference.

#### **RACE 5 – LADBROKES LAUNCESTON MILE – 1680M MOBILE**

BETTER DAY- Showed gate speed and led the event. Shifted out under pressure in the home straight. Driver fined.

COLBY SANZ- Underwent a post-race Veterinary examination after tiring to be beaten in excess of 71 metres. The gelding showed signs of an arterial fibrillation and was stood down for a period of 14 days, a Veterinarian certificate along with a ECG and must complete a satisfactory trial prior to its next race start.

KHAKI NUI NZ- Raced roughly at various stages.

MISS PAPENHUYZEN- Obtained an inside run in the home straight over the concluding stages.

NYACK- Pre-race blood test taken.

MAGICIAN- Shifted out under pressure in the run to the finish.

HULI NIEN- Raced roughly at various stages in the event. Back in the draw in mobile events.

Driver Jordan Chibnall, (BETTER DAY) pleaded guilty to a charge under provisions of AHRR168(1)(a) in that she carelessly allowed BETTER DAY to shift outwards in the home straight for the run to the finish which allowed MISS PAPENHUYZEN, (Rohan Hillier) to gain an inside run. Driver Jordan Chibnall was fined a sum of \$100.00. Stewards took into account her record in relation to this offence.

## **RACE 6 – STACEY LEAR PHOTOGRAPHY STAKES – 2200M MOBILE**

JO AN JO- Post-race swab sample was taken.

KERALA STAR NZ- Raced ungenerously in the score up.

GALAXY DANCER- Broke in the score up resulting in the gelding being out of position at the start. Will be placed outside the draw in future race starts.

SPACEWRITER- Pre-race blood sample taken.

SHARMEY- Inconvenienced in the score up and as a result broke gait. No action taken.

## **RACE 7 – TRAINER ENCOURAGEMENT SERIES HEAT TWO – 2200M MOBILE**

DUCANE- Driver suspended.

GYPSY AMOUR- Hung out in the score up resulting in the mare breaking gait and was placed on its last chance in the draw. Contacted marker pegs.

MONEYS NO ISSUE- Hung outwards at various stages. Contacted marker pegs – driver reminded of his obligations. Post-race swab sample taken.

GRIZZLY MONTANA - Hung inwards at various stages. Forced wider prior to the push out pole.

JUMPING JOLT- Pre-race blood sample taken.

Stewards questioned drivers Peter Dornauf, (DUCANE) and Kayleb Williams, (GRIZZLY MONTANA) into reasons why GRIZZLY MONTANA was forced wider on the track prior to the push out pole. Driver Peter Dornauf pleaded guilty to a charge under provisions of AHRR163(1)(b) in that he shifted DUCANE wider, forcing GRIZZLY MONTANA wider who had covered his wheel at this point prior to the designated point allowed. Peter Dornauf had his drivers license suspended for a period of 2 race dates. His suspension will commence on midnight 17-05-2024.

Driver Matthew Howlett following a steward's inquiry pleaded guilty to a charge issued under the provisions of AHRR162(1)(y) in that he failed to adhere to the minimum time standards for sections of a race by running 33.82 and 31.34 which equates to 65.16. This is over the 65.00 minimum standards allowed. Matthew Howlett was fined a sum of \$100.00.

## **RACE 8 – LADBROKES BLACKBOOK PACE – 2200M MOBILE**

The start of this race was delayed by 13 minutes due to the on track Medical Edge officers attending to a participant.

POWERHIT PASCOE- Hung inwards and contacted marker pegs.

MAGOMEDOV- Broke early in the score up, however no action was taken as the gelding was in position before dispatch. Forced wider in the run.

MISTA EAGLE- Post-race swab taken.

MAJOR DAVVIN- Raced fiercely at various stages in the event. Gave ground over the concluding stages. A post-race veterinary examination revealed a poor race recovery rate. Driver stated that he felt that MAJOR DAVVIN had choked down. MAJOR DAVVIN has been stood down from racing until the completion of a satisfactory trial.

STORMONT STAR- Pre-race blood sample taken.

Upon the conclusion of a steward's inquiry, driver Brodie Davis, (MAJOR DAVVIN) in the presence of claiming driver advisor Neville Webberley and driver Jack Laughner, (MAGOMEDOV) pleaded guilty to a charge issued under the provisions of AHRR168(1)(b), in that racing to the back straight on

the first occasion he shifted outwards which obliged MAGOMEDOV to cover more ground than necessary. Stewards took into account Mr Davis's early guilty plea, his good record under this rule and the race manners of MAJOR DAVVIN. Brodie Davis was fined the sum of \$250.00 and reminded of his obligations in similar circumstances.

### **RACE 9 – PACING FOR PINK PACE – 2200M MOBILE**

This race was rescheduled to start at 9.41pm.

A ROCKNROLL STAR NZ- Tired badly over the concluding stages of the event. A post-race Veterinary examination revealed no apparent abnormalities. Stewards spoke to trainer W Yole regarding the geldings poor performance. Mr Yole confirmed that the gelding had choked down. A ROCKNROLL STAR NZ has been stood down from racing until the completion of a satisfactory trail.

SERENGETI SUNRISE- Broke in the early part of the score up, however no action was taken as the gelding was in position before dispatch. Shifted out under pressure in the home straight for the run to the finish. Post-race swab sample taken.

MOST PERFECT MAJOR- Pre-race blood sample taken.

### **RACE 10 – FIND US ON FACEBOOK PACE – 2200M MOBILE**

ROYAL APPOINTMENT- Late scratching at the start on Veterinarian advice as the gelding was found to be lame in its off fore. ROYAL APPOINTMENT will be stood down from racing until a Veterinary certificate of soundness is received.

FLEETWOOD ROCK- Post-race swab sample taken.

ARDEN ROANOKE NZ- Pulled hard in the event.

LIL RIPPER NZ- Raced roughly at various stages.

WE SALUTE YOU- Pulled hard in the event. Placed on its last chance to race truly.

LAST OF THE MOHICANS NZ- Pre-race blood sample taken. Pulled hard in the event.

Stewards questioned Jordan Chibnall, (LAST OF THE MOHICANS NZ) in the presence of trainer Connor Crook, acting as Miss Chibnall's concession driver advisor and Kyle Pratten, (WE SALUTE YOU) into reasons why LAST OF THE MOHICAN NZ was forced wider on the track entering the back straight prior to the push out pole. Upon a conclusion of an inquiry driver Kyle Pratten pleaded guilty to a charge under the provisions of AHRR163(1)(b) in that he forced LAST OF THE MOHICANS NZ wider on the track causing the gelding to cover more ground than necessary prior to the designated point. Stewards took into account Mr Pratten's early guilty plea, his good record under this rule and the race manners of WE SALUTE YOU, who was pulling hard and over racing at the time of the incident. Driver Kyle Pratten was fined a sum of \$250.00.

Driver Rohan Hillier, (LIL RIPPER NZ) pleaded guilty to a charge issued under the provisions of AHRR168(1)(a) in that in the home straight on the final occasion, he shifted outwards to gain a clear run and placed Jordan Chibnall, (LAST OF THE MOHICANS NZ) in restricted room, causing her to check her runner resulting in LAST OF THE MOHICANS NZ racing roughly. Kyle Pratten, (WE SALUTE YOU) was racing to her outside. Stewards were of the opinion that WE SALUTE YOU had little or no bearing on this incident. In issuing penalty, Stewards took into account Mr Hilliers excellent record under this rule, his early guilty plea and the level of interference caused to LAST OF THE MOHICANS NZ. Rohan Hillier was fined the sum of \$200.00.
