My Girl Tenika underwent a post-race veterinary examination which revealed no obvious abnormalities. My Girl Tenika tailed the field and was beaten in excess of 52 lengths after being bumped on the first turn. Stewards deemed this performance unsatisfactory pursuant to GAR 129 and the greyhound must complete a Stewards Satisfactory trial before racing again.

General

Aston Fantastic completed an exhibition trial over 461 metres , beginning from box 3 the greyhound completed the course in 25.95 seconds.

Black Panama completed a Steward's trial as it had not raced for over 6 months. Weighing 29.2 kg and beginning from box 3 Black Panama ran a time of 19.90 and has been cleared to race all tracks.

Aussie Rocks completed a Steward's trial as it had not raced for over 6 months. Weighing 33.8kg and beginning from box 5 over 461 metres, Aussie Rocks ran a time of 27.92 and has not been cleared to race all tracks as it did not run the qualifying time. A post-race veterinary examination revealed a tear the left triangle muscle and the greyhound has been stood down from competing for 14 days.
